MINUTE 2 OF THE EXPERT PANEL

Invitations to comment

State Highway 1 North Canterbury – Woodend Bypass Project (Belfast to Pegasus) Substantive Application [FTAA-2512-1157]

1 April 2026

[1] This Minute addresses invitations to comment on the Substantive Application for the State Highway 1 North Canterbury – Woodend Bypass (Belfast to Pegasus) (**Project**) under section 53 of the Fast-Track Approvals Act 2025 (**the Act**).

[2] In accordance with section 53(2) of the Act, the Expert Panel must invite comments from persons listed in sections 53(2)(a) to (n) of the Act. Sections 53(2)(d) to (g) do not apply to this Application.

[3] The Panel considers the entities identified in **Appendix 1** must be invited for comment.

[4] Sections 53(2)(h) and (i) state that the owners and occupiers of the land the Application relates to and the land adjacent to that land must be invited to comment.

[5] Application Volume 1D¹ identified land within the Project site and land adjacent to that land. The Panel received a Memorandum from the EPA dated 24 March 2026 that also identified that same category of land. Application Volume 1D and the EPA Memorandum did not identify the same land, with the EPA Memorandum taking a more expansive view.

[6] Accordingly, the Panel exercised its judgment to decide which landowners and occupiers should be invited to comment having regard to EPA guidance², the context of the Application (which primarily relates to an existing State Highway Designation) and public perception that might arise from arbitrarily excluding contiguous residential properties in the vicinity of Pegasus Boulevard that were located a similar distance from the Designation boundary. In exercising its discretion under section 53(3), the Panel considered those properties were sufficiently exposed to the possible effects of the Application to justify their owners and occupiers being invited to comment.

[7] The EPA Memorandum advised that an unsolicited request to comment had been received from an individual. Having viewed the documentation from the individual that was provided to the Panel, it appears that they are primarily concerned about the existing Designation route and that is not something that the Panel has discretion over. Consequently, we have not invited the individual to comment.

[8] The Panel has determined that the owners and occupiers of the shaded land on the Maps in **Appendix 2** and as listed in **Appendix 3** should be invited to comment.

[9] The Panel considered MfE's Section 18 Report and determined under section 53(3) and that the following Māori groups may have relevant interests in the Project area and should be invited to comment:

- a. the owners of Part Te Wera Māori Reserve 873 Block, S.O. Plan 13785; and
- b. the owners of Lot 3 Deposited Plan 345904, 171 Gladstone Road, Woodend

[10] Other than that, the Panel determined it was not necessary to exercise its discretion under section 53(3) to invite comments from any other person or entity. The Panel is satisfied that the wide range of entities from whom comment is to be sought under section 53(2), as set out in Appendix 1, will ensure that all relevant information is before the Panel to enable it to make a robust decision in a timely manner.

[11] Section 54(1) of the Act requires that the Panel must specify in the invitation

a date for when comments must be received by the EPA on behalf of the Panel (which must be 20 working days after the date on which invitations are given under section 53).

[12] Invitations to comment were given on **Wednesday 1 April 2026**.

[13] Comments must be received by the EPA on behalf of the Panel on a specified date that is 20 working days after the date on which the invitation is given.

[14] Comments must be received by **Monday 4 May 2026**.

[18] In Minute 2 of the Panel Convener, the Panel Convener set out the key dates for the processing of the application. Those dates were based on the Panel inviting comments on 9 April 2026. As the Panel is inviting comments earlier than 9 April 2026, the key dates outlined in Minute 2 have been brought forward.

[19] The Panel is inviting comments today, 1 April 2026. Accordingly, comments are now due by 4 May 2026. The applicant's response is due on 11 May 2026. Subject to the processing of the application being suspended for any of the reasons outlined in section 60 of the Act, the decision on the application will be due on 29

July 2026.

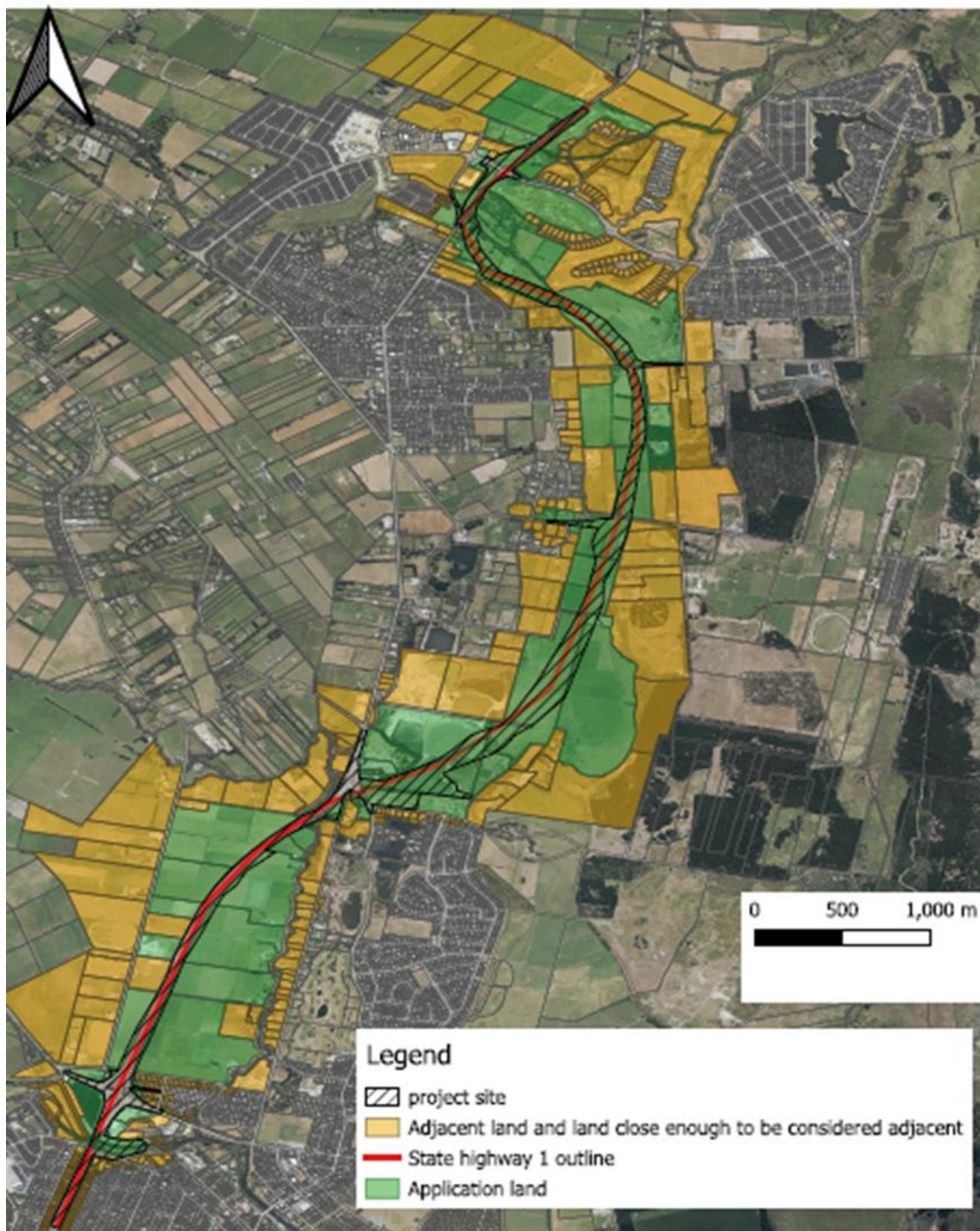

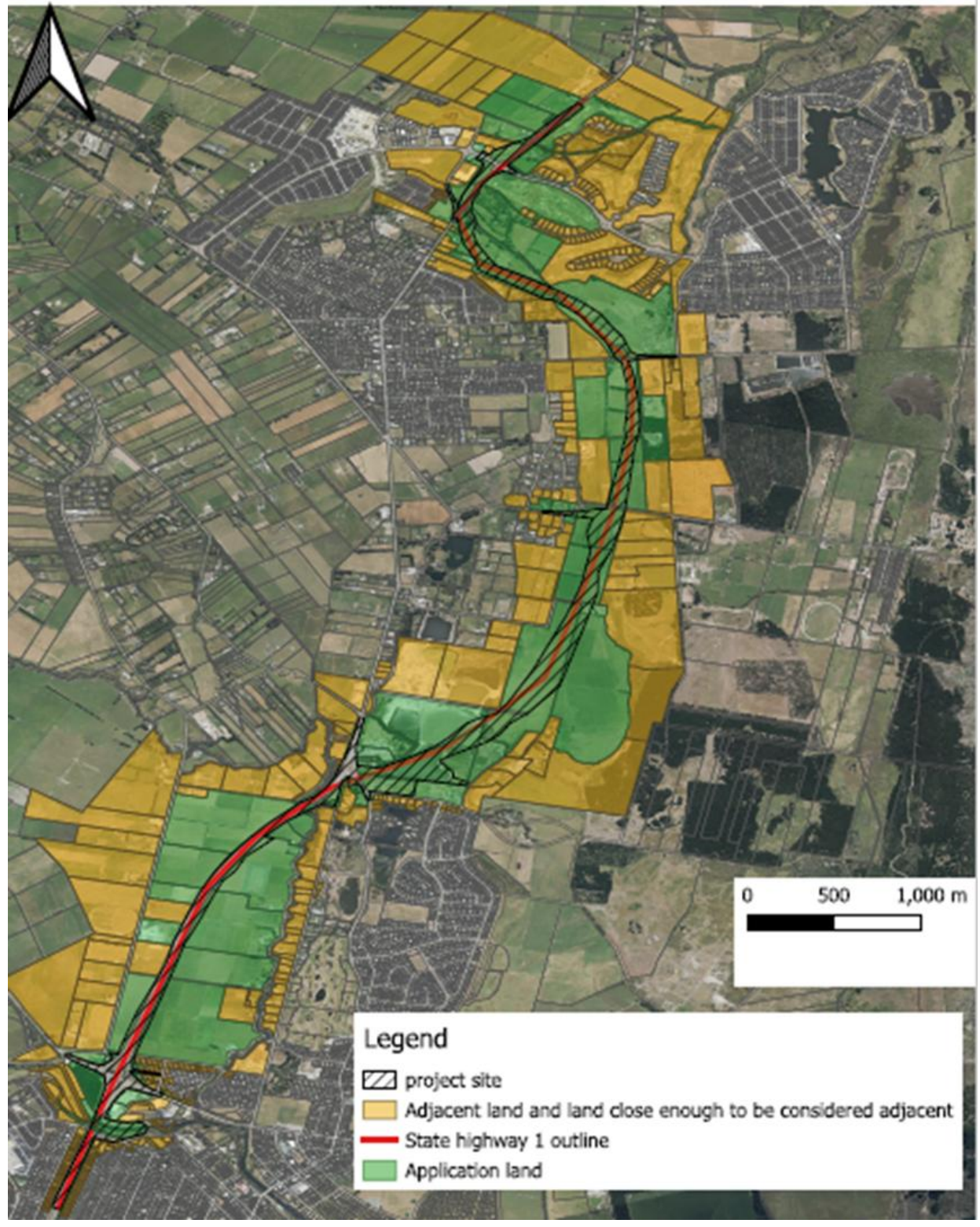
Map 1: Overview

State Highway 1 North Canterbury Bypass (Belfast to Pegasus) Project Map



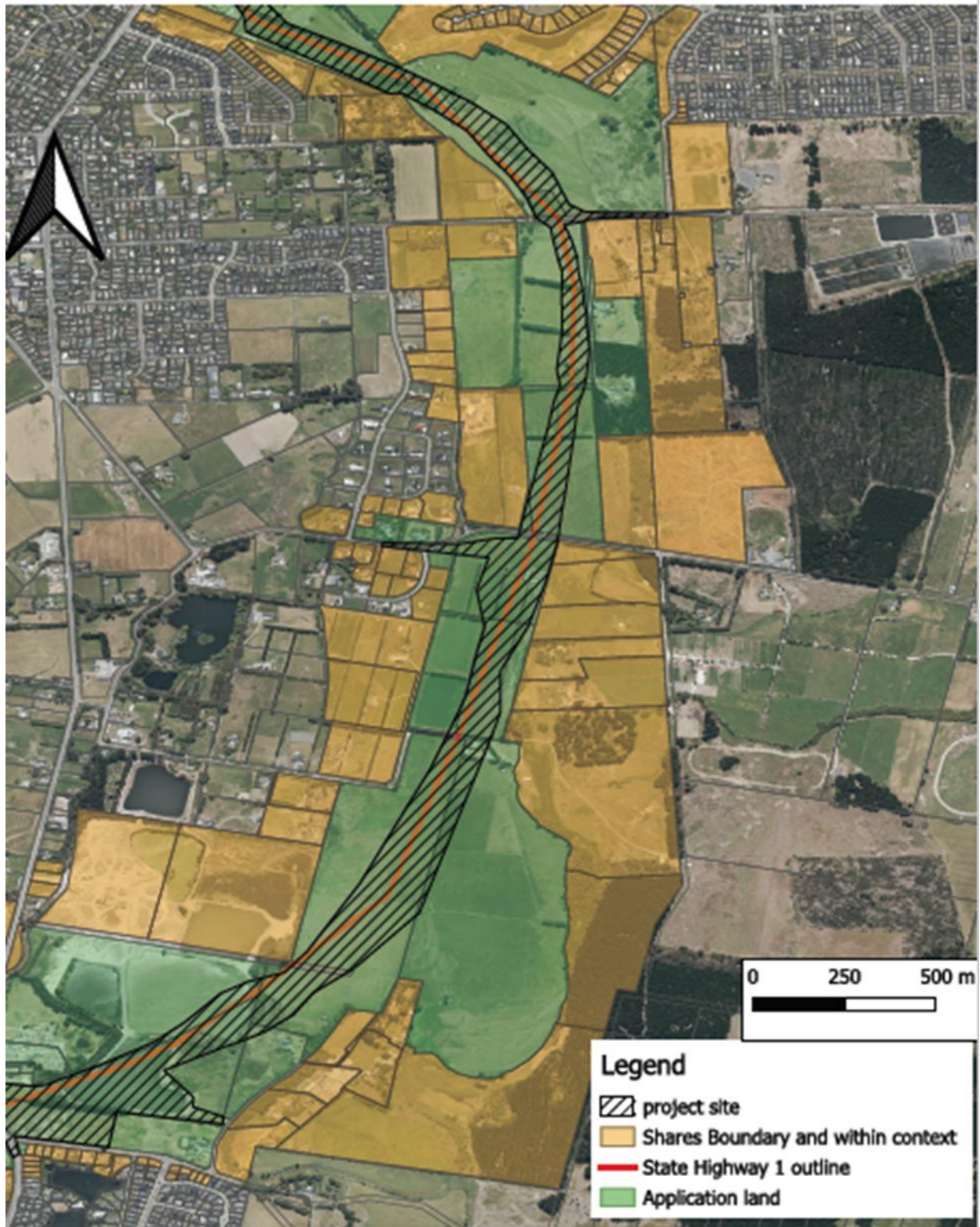
Map 2: Northern most section

State Highway 1 North Canterbury Bypass (Belfast to Pegasus) Project Map



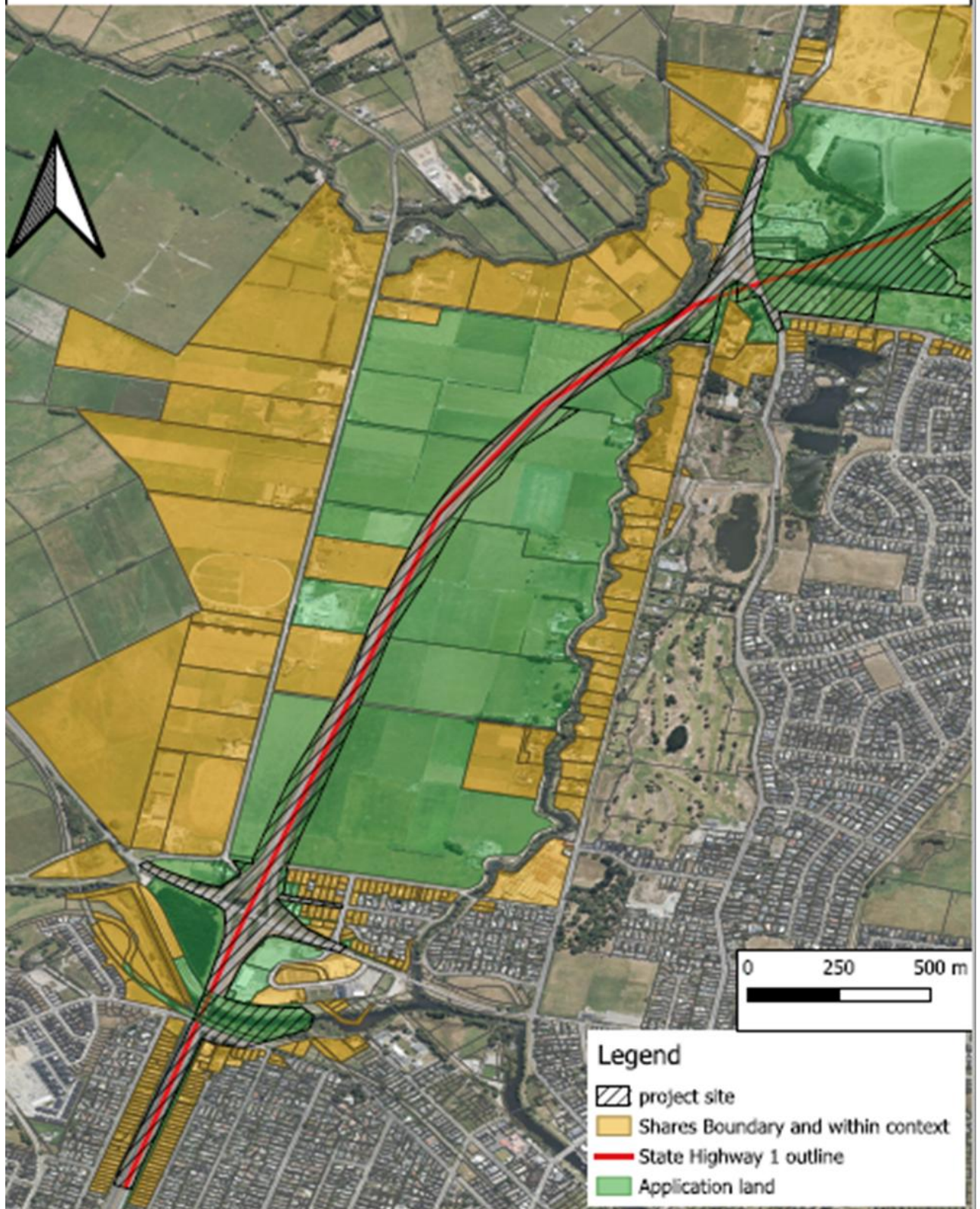
Map 3: Middle Section
