1	 SL: Context of project Covered the context and background information on Rogerson Block project. Residential and industrial use Specialist engagement for referral of application. Acknowledges progress made pre-lodgement and continued requirement for input. 	
2	 SL: Local site context Local site context Adjacent to proposed listed site SL1 Stage 1 Industrial – listed project and contiguous. SL1 Stage 1 residential area further east, but within SL1 Growth Cell and broader proximity to site.

	 Outlined ecological components. E.g., copper skink lizard, long tail bats, black mud fish, landform all part of wider consideration as part of a substantive application Wildlife Act authority anticipated for Copper Skink Lizard 	
	AS/DOC: highlighted the approach to ecological management should be kept consistent where possible in the wider Waikato context.	
5	Ecological concerns	
	Primarily focused on Copper Skink Lizards, and other matters above.	
	AS/DOC acknowledge the area is relatively low risk in terms of ecological concerns	
6	Fish Species	
	AS: there is potential for other fish species (as well as black mud fish).	
	AS: Due to fish passages being protected a fish management plan may be required to identify how to manage fish if they are in the area.	
	AS: This can be completed through a survey.	
	AS: Fish are a protected species so how will their movement be managed during earthworks?	
7	Copper skinks	
	AS: Copper skinks are considered in closer proximity than what may be highlighted in draft specialist report.	
	AS: consultation on where copper skinks would be relocated will be required.	
	AS: Wildlife Act to address copper skinks	
8	Long tail bats	
	AS: Bats are dispersed across Hamilton. The risk of bats is low, but not zero.	
9	Collective application	
	Broader recognition of only applying for a WAA where it is considered relevant. Part of further consideration with DOC as part of a substantive.	
11	Protective measures	
	CC: Application for Wildlife Act authority and amendments has new wording regarding expectations for demonstrating protective measures.	
	Insight into specifics that would be required.	
	Avoidance, mitigation, offsets.	



- AS used the example of managing birds (kingfish) nesting in trees. How would you address this through the various acts such as RMA, Wildlife Act, etc.
- AS: Waiwhakareke has a proposed (subject to funding) predator free fence, this is a potential location for relocating the lizards and would ensure greater protection than current measures that are in place. However, this fence is proposed and therefore a potential alternative.
- AS: Hamilton Zoo is an alternative option for a place for relocation of lizards providing Waiwhakareke fence is not complete or does not go ahead. Compensation to Hamilton Zoo.
- AS: The application must outline where the lizards will be placed and ensure they are relocated, protected and the population is not compromised. This would be addressed specifically as part of a Substantive Application and a Lizard Management Plan.
- AS: The after-release care of the species may be more of a priority than the long term monitoring of the species. As well as greater emphasis on protection of the site where the species is released

- DG: DOC will provide feedback following the meeting on what they would like to see in the substantive application.

- Iwi consultation outlined and acknowledged it is ongoing as part of the next phase of the Fast-Track project.
