National Policy Statement on Highly Productive Land 2022

The applicant provided advice that the site is classified as LUC 6. If Auckland Council agrees with the findings of the report, no further assessment would be required under the NPS-HPL for this activity.

National Policy Statement for Freshwater Management 2020 & National Environmental Standards for Freshwater 2020

A comprehensive suite of assessments relating to freshwater has been done, including on the impacts to groundwater, permanent and intermittent streams and wetlands and the habitats they provide.

Following best practice, the applicants have applied the effects management hierarchy and recommended mitigation and management plans, including stream and wetland offset packages and net gain delivery planting plans for wetland and riparian habitats. The local authority (Auckland Council) has also had the opportunity to review and provide feedback on freshwater effects and management and is best placed to respond to these matters. We would typically rely on Auckland Council's assessment of these matters.

National Policy Statement for Indigenous Biodiversity 2023 (NPSIB)

The application included a comprehensive Ecological Impact Assessment of the development site, including the impacts on indigenous vegetation and habitat.

To mitigate the effects the applicant has proposed an Ecological Management Plan that includes a significant package of biodiversity offsets. The biodiversity offset package includes revegetation, riparian planting, and pest and weed control in existing forests adjacent to the quarrying operation, as well as other offsite enhancements. The details are proposed to be addressed through consent conditions.

Auckland Council has had the opportunity to review and provide feedback and is best placed to respond to these matters.
