Out of Scope

To assist with the refinement of the documentation above, you will see from Attachment 7, Ecological Memorandum, that our ecologist has identified within the terrestrial ecological values section that copper skink (*Oligosoma aeneum*) have previously been found within 10km of the site. Accordingly, we intend to apply for a Wildlife Act Authority to cover the handling, capture and relocation of salvaged lizards, and accidentally kill of lizards as part of our Fast-Track Referral.

We look forward to receiving the invoice and a case manager to continue this consultation with DOC.

Thank you for your interest in engaging with DOC in consideration of your proposed Fast-track Approvals application.

The Fast-track (Cost Recovery) Regulations 2025 and DOCs Fast-track Cost Recovery Policy were published on 7 February 2024. Under the fast-track Cost Recovery regime applicants are required to pay an estimate of the costs prior to pre-lodgement consultation. The enclosed letter includes this estimate.
