Westpower's Waitaha Hydro Scheme Fast Track Application Identification of Existing Resource Consents

The West Coast Regional Council has undertaken a review of the consents granted on land intended to be utilised as part of the proposed Waitaha Hydro Scheme fast track application. Consents existing on the land to be utilised by the hydro scheme are identified in Table 1 below. None of the existing consents are in a situation where sections 124(C)(1)(c) or 165ZI would prevent the Waitaha Hydro Scheme fast track applications from being fully exercised.

Rather than frustrating the operation or renewal of these consents, they are contingent on the Waitaha scheme going ahed.



<u>Westpower Waitaha Scheme Fast-Track application – pre-application requirement – Identification of existing resource consents</u>

The Westland District Council has undertaken a review of the consents granted on land intended to be utilised as part of the proposed Waitaha fast-track application.

The Council confirms there are no existing resource consents within the Project Site to which section 124C(1)(c) of the Resource Management Act (RMA) would apply if the approvals (resource consents) sought in the Application were to be applied for as a resource consent under the RMA; and additionally there are no existing resource consents of that kind located within the Project Site.
