



### **Fast-track Approvals Act 2024**

#### **MINUTE 1 OF THE EXPERT PANEL**

Invitations to comment on the application Southland Wind Farm [FTAA-2508-1095]

#### 19 November 2025

- [1] This minute addresses invitations to comment on the application under section 53 of the Fast-track Approvals Act 2025 (**the Act**).
- [2] In accordance with section 53(2) of the Act, the Expert Panel must invite comments from persons listed in sections 53(2) (a) to (n) of the Act. Sections 53(2)(d) to (g) and section 53(2)(l) do not apply to this application. The Panel considers the persons identified in **Appendix 1** must be invited for comment.
- [3] Section 53(2)(h) and (i) state that the owners and occupiers of the land adjacent to the land the application relates to must be invited to comment. The Applicant in Part L of the application included a list of property owners and occupiers adjacent to the site.
- [4] After considering the information from the Applicant and the advice from the EPA, and having now reviewed the application material, the Panel has determined that the owners and occupiers of land shaded orange on the Maps in **Appendix 2** and listed in **Appendix 3** should be invited to comment.
- [5] The Panel has considered section 53(3) and determined that it is appropriate to invite comments from the following parties:

- a. Chief Executive of PowerNet Limited
- b. Te Ao Mārama Incorporated (TAMI)
- c. Environmental Defence Society
- d. West Catlins Preservation Society
- e. Parliamentary Commissioner for the Environment
- f. The owners and occupiers of land shaded purple and yellow on the Maps in **Appendix 2** and listed in **Appendix 4**.
- [6] The date invitations to comments will be given will be Wednesday, 19 November 2025. Comments must be made to the EPA:


