

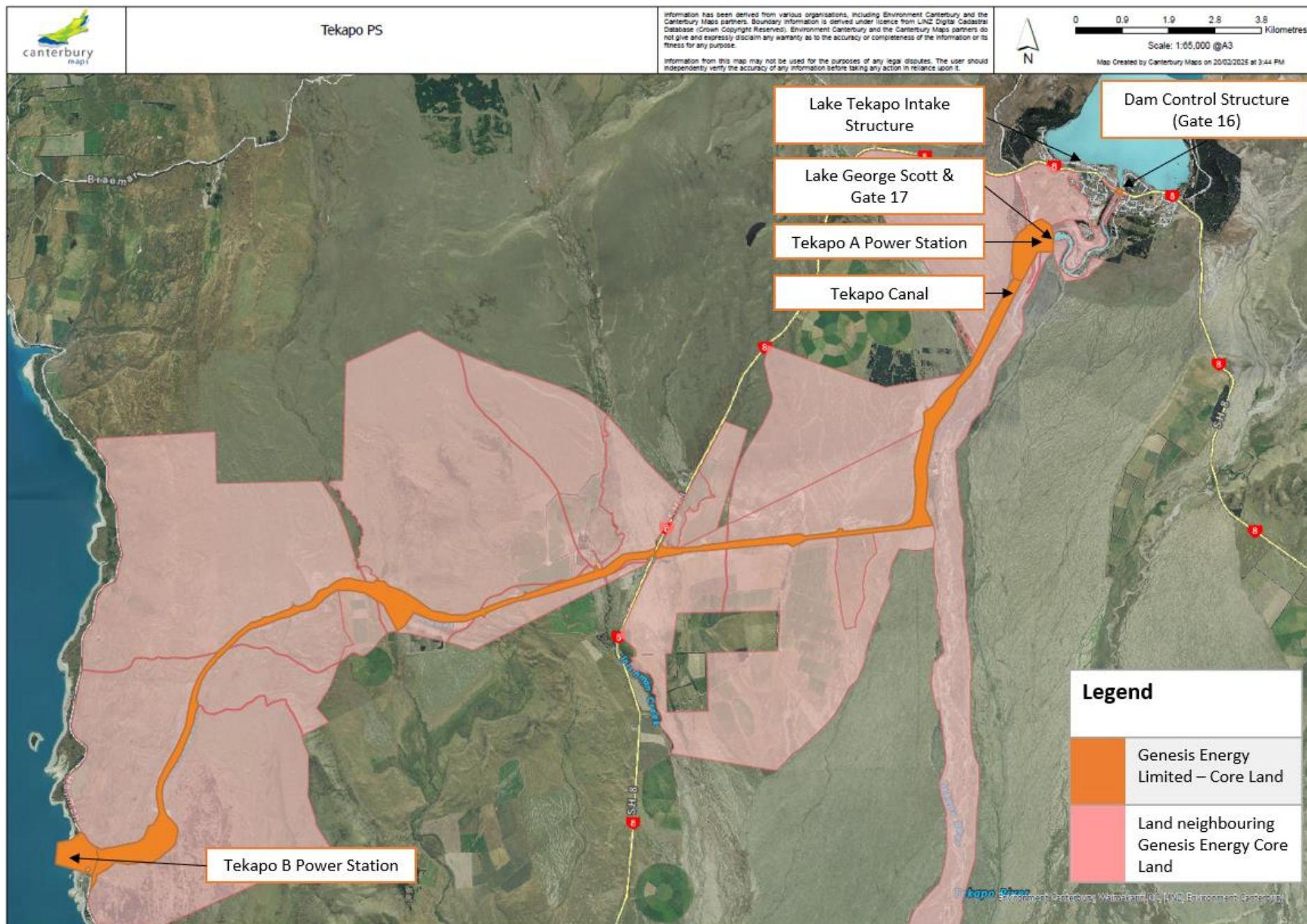
## Appendix C: Adjacent Landowners

**Table 1** and **Figure 1** identify landowners and land adjacent to the Tekapo Power Scheme 'Core Land.' Core Land refers to land and infrastructure owned by Genesis, including the Lake Tekapo Intake Structure, Gate 16, Lake George Scott, Gate 17, Tekapo A Power Station, the Tekapo Canal and the Tekapo B Power Station. In addition to Core Land, Genesis holds easements for Lake Takapō, Lake Pūkaki, and the Takapō River.
