



MINUTE 2 OF THE EXPERT PANEL

Invitation to comment Milldale [FTAA-2503-1038]

- [1] This minute addresses invitations to comment on the application under section 53 of the Fast-track Approvals Act 2025 (the Act).
- [2] In accordance with section 53(2) of the Act, the Expert Panel must invite comments from persons listed in sections 53(2) (a) to (n), where relevant. **Appendix 1** provides the list of prescribed persons relevant to this project.
- [3] Section 53(2)(h) and (i) state that the owners and occupiers of land to which the substantive application relates, and the land adjacent to that land, must be invited to comment. The Application included an appendix (*Appendix 1D: Names and addresses of adjacent owners and occupiers*) that identified the names and addresses of owners and occupiers of the project site and the land adjacent to the site. The EPA has also provided its advice to the Panel based on the Guidance Note entitled: *FTA Guidance Material Identifying Adjacent Land*.
- [4] In determining which land parcels may be considered adjacent to the site, the Panel are of the view that the proposed offsetting site is 'land to which the substantive application relates' and therefore the owners and occupiers of that land, and the land adjacent to it, are invited to comment. The list of land parcels whose owners and occupiers will be invited to comment is included in **Appendix 2**.
- [5] The Panel has considered section 53(3) of the Act and determined that the following additional parties should be invited to comment due to the applicant having consulted with them regarding the application:
