- POAL welcomes the comments provided to the Panel in respect of the Project, and acknowledges all persons and entities who have taken the time to comment, particularly in light of the timeframes available under the FTAA.
- 4. POAL is happy to be able to respond in a constructive manner to the comments that have been provided, and will continue to work with interested parties as the Project progresses.
- 5. POAL has carefully considered the comments received by invited parties, and has set out specific responses to each party in the memorandum attached. For completeness, POAL has provided responses to all parties that commented. The memorandum includes an updated resource consent
