## Final offer to settle Ngāti Porou ki Hauraki historical Treaty of Waitangi claims

This letter sets out the Crown's best and final offer to settle Ngāti Porou ki Hauraki's historical Treaty of Waitangi claims.

The settlement package set out in this offer is the result of years of hard work on both sides. The journey has been long, and we are now at the close of substantive negotiations.

I have attached a summary of the Crown's best and final offer to this letter. The offer represents an extensive package of redress that is befitting of Ngāti Porou ki Hauraki cultural, spiritual and traditional associations. You have worked hard to ensure Ngāti Porou ki Hauraki interests have been appropriately recognised which is reflected in the settlement package.

In addition to the redress outlined in the attached document Ngāti Porou ki Hauraki will also receive redress through the Pare Hauraki Collective Redress Deed.

This offer is subject to overlapping claims being addressed to the Crown's satisfaction. I am advised my officials have discussed this process with you.

I seek your formal response to this offer, either to me or the Crown's Lead Negotiator, Hon Rick Barker, by 17 January 2018.
