#### INTRODUCTION

#### **Qualifications and Experience**

- 1. My name is Alan John Eggers.
- 2. I am a professional geologist with over 40 years of international experience in mineral exploration, metal mining, mine management and discovery of base metals, precious metals, iron ore, uranium and industrial minerals.
- Although this statement is not expert evidence, in accordance with the Code of Conduct for Expert Witnesses contained in the Environment Court's Practice Note dated 1 January 2023, I set out my relevant experience and qualifications.
- 4. I am the executive chairman of Trans-Tasman Resources Limited (TTR), a position I have held since 1 October 2014. Currently I am also an executive director of ASX listed Manuka Resources Limited, director of TTR Marine Limited, Mt Boppy Resources Pty Ltd and Ocean Technologies Limited, and managing director of Wesmin Corporate Pty Ltd.
- 5. Previously I have held the positions of:
  - (a) Founding director, chief executive officer and managing director for 20 years of ASX and NZX listed mining company Summit Resources Limited;
  - (b) Executive Chairman and chief executive officer of ASX listed Manhattan Corporation Limited;
  - (c) Director of ASX listed Zedex Minerals Limited; and
  - (d) Director of the Australian Uranium Association.
- 6. I hold a Bachelor of Science (B.Sc), Bachelor of Science with Honours (B.Sc 1st Class) and Master of Science (M.Sc) in economic geology, all from Victoria University of Wellington. I have also completed professional development courses in

mineral exploration, mine management and mineral economics at the Australian Mineral Foundation (AMF). I am a fellow of the Society of Economic Geologists (FSEG), a fellow of the Australasian Institute of Mining and Metallurgy (FAusIMM), and a member of the Australian Institute of Geoscientists (MAIG).

7. In the interests of transparency I disclose that I maintain, with my associates as defined in the Australian Corporations Act (cth), shareholdings in TTR's parent entity Manuka Resources Limited.

#### **Involvement in Project**

- I have been involved, and held an investment, in TTR's New
   Zealand iron sands project from its inception in 2008;
- 9. Since my appointment as Executive Chairman in 2014 I have held primary responsibility to manage and direct the strategic direction of the company and for the technical, corporate, financial activities and owners and compliance reporting of TTR, its staff, advisers and consultants. This includes direct involvement in, and oversight for TTR, of TTR's 2016 application for marine consents under the EEZ Act, all subsequent litigation from 2017 to 2021, the reconsideration process from 2021 to 2024, and TTR's current application under the Fast-Track Approvals Act 2024 (Fast-track Act).

#### **Scope of Evidence**

10. This evidence will cover proposed mining activities in the STB, the work done by TTR to date in seeking permits and consents for the proposed mineral recovery and export operation, outline of the mineral recovery proposal, permitting, investment, scale and scope of the operation, technology, alignment with government policy and objectives, alignment with the primary purposes of the EEZ Act and Fast-track Act, examples of the attempted engagement with tangata whenua, the regional and national benefits of the project and

key responses to address comments received by invited parties;

- 11. I have provided updated summaries of engagement and consultation with:
  - Commercial Fisheries (Talley's) and Seafood New Zealand in Appendix 1;
  - Offshore Wind Energy Stakeholders in Appendix 2: and
  - Iwi Groups in Appendix 3.

These are all summarised in the tables provided with the responses to comments that have been provided to the Panel.

#### **BACKGROUND TO TTR'S APPLICATION**

- 12. TTR has held numerous prospecting, exploration, and now, mining permits granted by the Crown along the West Coast of the North Island since 2008.
- 13. TTR currently holds 635km<sup>2</sup> mineral exploration permit MEP54068 granted on 19 December 2012 and 243km<sup>2</sup> mineral mining permit MMP55581 granted on 2 May 2014.
- 14. TTR has made an investment of over \$88 million in mineral exploration, geophysical surveys, drilling, sample analysis, metallurgical test work, bulk sampling, mineral pilot plant processing, engineering studies, marine research, ROV video surveys of the seafloor, JORC mineral resource reports, prefeasibility studies, concentrate marketing studies economic evaluation, discounted cash flow modelling and economic impact analyses and environmental approvals and court challenges.
- 15. Extensive consultation and stakeholder engagement has been undertaken since 2009 with a range of local and

regional authorities, ports, fisheries, oil and gas businesses, community and recreational groups and clubs as provided in our FTA application and my updated consultation statement provided to the FTAA Expert Panel, noting that after an encouraging start, meaningful engagement with tangata whenua has not been possible, as I will explain later.

- 16. TTR's current application is consistent with the MBIE Briefing for the Incoming Minister for Resources on 27 November 2023 (MBIE Briefing) where they stated vanadium occurs as a significant by-product, up to five percent, within the substantial iron sand deposits on and offshore the west coast of the north Island. It is a key component in redox flow batteries and high strength steel.
- 17. MBIE Briefing further states New Zealand's mineral potential extends into the marine area and these minerals could support clean technology and other supply chains. For example iron sand along the west coast of the North Island sitting in 20 to 50 metres of water could supply iron for steel making, vanadium for battery storage and titanium for clean energy technology.
- 18. The MBIE 2023 briefing paper estimates an 'in the ground' value of Taranaki iron sand at NZ\$100 billion and additional offshore iron sand deposits of up to NZ\$275 billion.
- 19. Iron and steel are essential for transport, communications, construction, building, industry, manufacturing and processing technologies, EV's, wind & solar, power transmission; critical minerals vanadium for steel, rebar & utility scale battery storage (VRFB); and titanium for aerospace, satellites, paints, paper, white goods, electronics, medical, building products.
- 20. The Earth Sciences NZ (formerly GNS) Report on Mineral Potential for New Zealand released 29 August 2024 identifies TTR's Taranaki VTM iron sand deposits, offshore in the STB, with

reported 3.2Bt JORC Indicated and Inferred Resources of vanadium and titanomagnetite that grade 10.2% Fe<sub>2</sub>O<sub>3</sub>, 0.05%  $V_2O_5$  and 1.0% TiO<sub>2</sub> as a resource that has potential to be developed.

- 21. At the proposed mining rate, over 20 years, 50Mt per annum of iron sand will be dredged from the seafloor, processed onboard a processing vessel where 5Mtpa (10%) VTM concentrate will be recovered by mechanical magnetitic separation and the residual iron sands (45Mtpa) will be returned to the seabed in a controlled manner from where it was previously harvested.
- 22. The VTM will be recovered from the seabed in waters from 20 to 50 metres deep via suction dredging utilising electrically driven seabed crawler technology developed and, for first 2 years, operated by, De Beers Marine (DBM) and Royal IHC technology partners. DBM and IHC have built and commissioned 8 similar seabed crawlers over the past 35 years and successfully used the technology to recovered seabed sediments in similar depth waters off the southwest coast of South Africa and Namibia.
- 23. DBM will also undertake training of local TTR employees and contractors to operate, maintain and service the seabed crawlers.
- 24. Other features of TTR's proposed activity include:
  - (a) a small physical footprint with only 300m x 900m (0.27km²) area of disturbance at any time;
  - (b) Very low, <50% carbon emissions compared to other hard rock iron ore concentrates with no heavy machinery mining & haulage fleets, open pits or overburden stripping, waste or tailings dumps, haul roads, energy intensive crushing & grinding circuits, roads, railroads or ports required; and

- (c) lowest carbon intensity 62kgCO<sub>2</sub>/t versus 120-250kgCO<sub>2</sub>/t for competitors iron ore concentrates world-wide.
- 25. No chemicals, reagents or toxins will be used in the recovery and mineral processing of the 5Mtpa VTM concentrates that will grade 57%Fe, 0.5%V<sub>2</sub>O<sub>5</sub> & 8.4%TiO<sub>2</sub>.
- 26. The 5Mt VTM concentrates exported will contain iron ore and  $18,000t\ V_2O_5$  (vanadium pentoxide) or  $10,000t\ V$  (vanadium metal) at 77% metallurgical recovery and  $325,000t\ TiO_2$  (titanium dioxide).
- 27. 2024 global vanadium production (V) was:

• China 39,200t;

Russia 11,760t;

South Africa 4,480t; and

• Brazil 2,800t.

At TTR's proposed rate of production at 10,000t Vpa it would make the operation, and New Zealand, the world's third largest producer of this critical mineral and the western world's largest producer.

- 28. Taranaki VTM Project was listed in Schedule 2 to be considered for Fast Track consent as one of the 11 mining projects on 6 October 2024 by the Fast Track Projects Advisory Group.
- 29. On 31 January 2025 the Minister for Resources announced New Zealand's Critical Minerals List and vanadium and titanium are both included. These two critical minerals reported in TTR's mineral resource discovery are also included in USA, UK, EU, AUS, CAN and China's Critical Minerals Lists.
- 30. Also, on 31 January 2025 the Minister announced A Minerals Strategy for New Zealand to 2040. The strategy states growth

- will be underpinned by scaling up our existing exports and by realising new mineral opportunities.
- 31. TTR's offshore iron sand deposits containing vanadium and titanium minerals used in iron and steel, super alloys, pigments, carbides' chemical catalysts and redox flow batteries are included in the Minerals Strategy and will make a major contribution to the Government's objective of doubling the value of NZ's mineral exports to \$3 billion by 2035.
- 32. The world class VTM resource discovered offers NZ the opportunity to be a long term iron ore exporter and lead producer of critical minerals internationally.
- 33. Consents are sought for 35 years in total to accommodate the pre-commencement marine monitoring, 20 years of mining activity and at least 5 years of post-mining activity monitoring to ensure TTR has complied with its consent conditions and rehabilitation and seabed ecology recovery is complete.
- 34. To prepare TTR's FTA Application TTR commissioned a large body of new work, building upon the work that went into its previous applications. This new work includes:
  - (a) a revised 2025 pre-feasibility study (PFS);
  - (b) new JORC mineral resource statement including vanadium & titanium;
  - (c) 2025 metallurgical report on critical mineral recoveries (V<sub>2</sub>O<sub>5</sub> & TiO<sub>2</sub>),;
  - (d) 2025 NZIER economic impact assessment (EIA);
  - (e) ongoing consultation updated; and
  - (f) reconsideration of all prior assessments of effects, and updating those assessments where necessary in a new application, prepared in accordance with the

new legislation and taking into account relevant aspects of previous Court decisions.

- TR's application includes 109 proposed operating conditions that include Pre-commencement Environmental Monitoring Plan (PCEMP), Environmental Monitoring and Management Plan (EMMP), Seabird Effects Mitigation and Management Plan (SEMMP), Marine Mammal Management Plan (MMMP, Collision (Loss of Position) Contingency Management Plan (CCMP), Simultaneous Operations Plan (SIMOPS, Biosecurity Management Plan (BMP, Kaimoana Monitoring Programme (KMP) and a Post- extraction Monitoring Plan (PEMP).
- 36. As described by a range of leading environmental and resource management professionals, the project will have environmental effects that are not significant and able to be comprehensively managed by a range of conditions that are endorsed by those professionals.
- 37. Approval and development of TTR's Taranaki VTM project is an opportunity to develop new +\$1 billion export industry that propels NZ into top ranked producer critical minerals & green steel feed, uses proven seabed mineral recovery and mineral processing and concentrate shipping technologies, with experienced operators (De Beers Marine with over 35 years of seabed mining and seabed crawler operational experience in marine mineral recovery and environmental research and monitoring).
- 38. TTR has discovered and defined a world class resource with significant exploration upside that delivers low Q1 operating costs around US\$27/t and will be sustainable and internationally competitive.
- 39. The Taranaki VTM Project will deliver jobs and economic growth and be:

- One of NZ's largest export earners with >\$850m export income pa;
- Major employer of high value jobs in Taranaki and Whanganui regions;
- Delivers regional investment;
- 35 years plus marine research; and
- Strong government revenue streams.

#### MANA WHENUA ENGAGEMENT

- 40. It is to my deep regret that TTR has, despite our concerted and repeated efforts, failed to establish a meaningful and mutually beneficial relationship with Ngāti Ruanui, Ngā Rauru Kītahi, Ngāruahine, and other tangata whenua groups who have a relationship with the South Taranaki Bight.
- 41. I want to make it clear that TTR acknowledges and respects Ngāti Ruanui as mana whenua for the area and their role and obligations, and those of all the South Taranaki iwi, as kaitiaki over their rohe. To this end we would like to think there is a possibility of TTR being able to meaningful engage in the future with mana whenua, and all other South Taranaki iwi.
- 42. I do wish to set the record straight regarding the repeated assertions from iwi that we have failed to engage meaningfully and I provide one example, in some detail, that I trust shows that we have genuinely tried to engage, but have been rebuffed.
- 43. In 2013, as part of the preparation for our first application to the EPA, Ms Debbie Ngarewa-Packer as a representative of Ngāti Ruanui was approached to discuss the project and how a working relationship might be progressed. During those conversations Ms Ngarewa-Packer agreed that Ngāti Ruanui would provide a Cultural Impact Statement (CIS), for which commercial terms were discussed and agreed.

- 44. In that regard, between 1 April 2013 to 31 March 2014 TTR made four payments to Ngāti Ruanui totalling \$63,377.65 for them to assess the application and prepare the CIS. Bank records can be provided if it would assist the Panel.
- 45. Ngāti Ruanui had not provided a CIS to TTR by the time the application was due to be heard in 2014.
- 46. In June 2014 the EPA's Decision Making Committee declined TTR's environmental consent application. TTR appealed this decision to the High Court, but quickly withdrew it in favour of preparing and lodging a new application with the EPA.
- 47. As part of preparing the second application TTR re-engaged with Ngāti Ruanui and again asked them to prepare the CIS they had previously agreed to provide.
- 48. On 18 February 2015 Ms Debbie Ngarewa-Packer agreed to prepare the CIS provided TTR paid their legal costs associated with TTR's 2014 appeal to High Court, and on 19 February 2015 TTR made a payment to Ocean Law in Nelson for \$7,518.79. Again, correspondence and bank records can be provided, if required.
- 49. On 3 September 2015, Shawn Thompson, Tokatumoana Walden (TTR Management, retained at Ms Ngarewa-Packer's suggestion to facilitate iwi engagement) and I met with Ms Ngarewa-Packer and her advisers in Hawera where she again committed to provide the CIS by early 2016 so it could accompany TTR's second application to the EPA.
- 50. On 27 January 2016, I had a phone meeting with Ms Ngarewa-Packer to endeavour to have the CIS completed and on 17 February 2016 I instructed TTR's legal advisers AHM to write to Ms Ngarewa-Packer requesting a meeting to resolve outstanding issues and have the CIS report completed.
- 51. Due to the lack of progress with Ngāti Ruanui in preparing the CIS, TTR felt it was between a rock and a hard place we

recognised that Ngāti Ruanui were mana whenua but we had been unable to gain any traction on how to understand what their concerns were, let alone how to address them. Because we felt we had no other option, we engaged Tahu Potiki and Buddy Mikaere to complete a Cultural Values Assessment and provide expert evidence for the EPA hearing in 2017.

- 52. In October 2016 Ngāti Ruanui sought an extension of time by the EPA's DMC in order to allow them to consider and consult internally on the cultural impacts of the application, including TTR's CVA. No feedback was provided to TTR and, regrettably, all engagement since has been through the Courts or via our respective lawyers.
- 53. In summary, TTR has repeatedly attempted to engage with Ngāti Ruanui, and in fact provided \$70,896.44 to them to review TTR's consent applications and prepare a CIS that was never provided. All I can say is that the situation is regrettable, but I am satisfied that we have acted in good faith.
- Despite previous attempts to engage being rebuffed, TTR again sought and did meet with Ngāti Ruanui in Hawera in September 2025. Ngāti Ruanui made it clear in the meeting that it didn't accept TTR's expert scientific reports and evidence, and remained opposed to the project.
- 55. Regarding iwi consultation more generally, this has continued since the application was lodged earlier in the year (refer Appendix 3) and is summarised in the tables provided with the responses to comments that have been provided to the Panel.
- 56. Despite meaningful engagement not having occurred, TTR has proposed a suite of consent conditions (conditions 60 to 64 and 72 to 84) that are intended to provide mana whenua with meaningful and active roles in monitoring the environmental and, particularly cultural, effects of the project

and exercising kaitiakitanga. To the extent that mana whenua wish to do so, TTR remains willing to further discuss conditions during the process, and amend/add to them as necessary.

#### **Dear Andrew**

#### TTR Taranaki VTM Project in South Taranaki Bight

As you will be aware the Fast-track Approvals Bill is currently going through Parliament and is due to be passed into law before Christmas.

Trans-Tasman Resources' project to mine the iron sands off the coast of Taranaki is one of 149 projects listed in the Bill to be fast-tracked. This means we are likely to go before an Environmental Protection Authority (EPA) Panel next year and the Panel will determine if our project should proceed.

We recognise that, while our project has support, some opposition also remains.

In the past few months we have engaged with a range of people and organisations in the Taranaki and Whanganui community to provide information, increase understanding of the project, and to help us understand their concerns and how we can best address and mitigate these.

To be frank, some groups are not interested in engaging with us and others have chosen not to accept our expert scientific reports on the project's benefits and impacts. That is disappointing, but it is their right.

We are writing to you as Talley's has opposed our previous applications.

We understand that Talley's are concerned about the potential for adverse effects our activities may potentially have on your existing commercial fisheries interests in the South Taranaki Bight.

We are interested in engaging with you to better understand the basis for your position, to answer questions you may have and to share more detail on the project. We can demonstrate that our proposed project to recover VTM concentrate in the South Taranaki Bight will not have any adverse effects on, or interfere with, your existing commercial rights.

We have spent time specifically addressing the concerns of the commercial fisheries and aquaculture in the area and, after consultation, gained the support of, and reached an operating agreement with, Sanford Ltd for TTR to operate in the South Taranaki Bight.

It is important to us that we take the time and opportunity to improve our mutual understanding with Talley's. We may not agree on everything, but we may also be able to find some common ground to build from.

Please consider meeting in the New Year to discuss the project, your concerns and how we may better work together going forward – for the benefit of all who operate or may operate in the Bight.

#### **Talleys and Commercial Fishing Interests**

#### **Nici Gibbs Expert Report Fisheries**

I had a call from Doug Loder (Talleys) yesterday (24 February) asking if it is OK for Talleys and Seafood NZ et al to use Nici Gibbs of Fathom Consulting to provide a 'scoping document' and conditions and management plan to give the fishing industry comfort TTR will manage our operation and monitoring to ensure there are no adverse effects or detriment to their commercial interests.

He advised that TTR had previously engage Nici to provide a Fisheries Report on STB.

I agreed it was OK for them to engage Nici. Her 2013 report, updated November 2015, is attached.

I had not reviewed Nici's report prior to agreeing with Doug on her engagement.

Nici's key findings and conclusions were:

#### 3.4 Broader impacts of spatial displacement

As noted in section 3.2 above, the level of displacement of commercial effort and catch as a result of the mining operations is likely to be minimal in the trawl fisheries, and small in the set net fishery (entailing some possible displacement of school shark catch). The relatively small amount of displacement in both cases is unlikely to result in any wider negative impacts on the commercial fishing industry. In particular, there are:

- no anticipated reductions in quota value;
- no anticipated downstream business impacts on fish processing or other fisheries-related services;
- no anticipated increased sustainability risks to fish stocks as a result of displaced effort and catch; and
- no anticipated increased risk of conflict with other resource users.

#### 3.5 Summary of suggested mitigation measures

#### **Eggers Statement of Evidence 13 October 2025**

Mitigation measures that could be adopted by TTR to minimise any impacts of the proposed mining activity on commercial fishing in the South Taranaki Bight include:

- developing a contact list of companies and vessels operating in the area;
- designing and implementing a communication system to alert vessel operators to the intended location and duration of mining activities on a regular basis;
- developing a more precise understanding of the location and seasonality of set net effort in the area of the mining operation, and designing the mining operational plan to minimise any impacts on this fishery; and
- undertaking the mining operation in a manner that minimises the risk of sediment dispersal in the wider marine environment.

These outcomes [no impacts and fisheries consultation - taken care of in the Technical Revue Group (TRG) of which they are a member] are consistent with Alison MacDiarmid's (NIWA) conclusions on impact on commercial fisheries and fine with TTR.

Should she now produce conflicting outcomes and conditions to operate would be of concern and raise a 'red flag' around expert credibility.

Again, it was good to catch up on Thursday and discuss the part of your submission relating to conditions SNZ would like to see included in TTR's proposal to harvest iron sands in the South Taranaki Bight.

I also really appreciate that you forwarded your full submission to me late on Friday to enable TTR to begin working on its response to your recommendations.

However, I was somewhat disappointed to read point 8 below:

In July 2025 SNZ approached TTR with a view to discussing, and potentially reaching agreement on, the conditions recommended in these comments. To date, no resolution has been reached but SNZ remains open to further discussion.

The facts are TTR approached Talley's in December last year to meet and discuss how we could work together to mitigate Talley's concerns about the project. Talley's responded and we met with Talley's and their legal team in late January. At the meeting, Talley's made clear they wanted a 'degree of comfort' that its commercial fishing operation would not be impacted by the project. Talley's was to come back to us with what that might look like and we forwarded information to Talley's following the meeting to support the process.

We never heard back from Talley's. Instead, you reached out in July and TTR responded and we met and discussed the project in broad terms. The conditions contained in your submission were never discussed at this meeting, though there was intent from both parties to work together to reach agreement. You shared SNZ's conditions with me (TTR) last Wednesday afternoon and we met to discuss them on Thursday morning. There was no time or opportunity to reach agreement on them.

I therefore find this comment misleading and a mischaracterisation of our engagement. TTR has been a proactive, willing and open participant in this process.

Can you please update your submission to the expert panel and remove this point?

#### TTR South Taranaki Bight Seabed Mining Overview

TTR's 3.2 billion tonne (Bt) vanadium rich titanomagnetite (VTM) resource located over 22km offshore in the South Taranaki Bight (STB) is a world class deposit capable of delivering sustainable jobs, much-needed infrastructure investment in Taranaki/Whanganui, taxes and royalties to the Crown, at no cost to New Zealand taxpayers, with a minimal, confined and only a very short term localised impact on the STB marine ecosystems.

On 15 May 2024 a consortium of proponents issued a briefing paper on their proposed offshore wind farm to be established in the South Taranaki Bight (STB).

TTR makes the following observations and comments on their paper;

- TTR has long standing existing 'property rights' in the STB in the form of government granted exploration and mining permits and an application for extension to a mining permit.
- TTR has material risk capital invested in these permits in excess of >\$85 million expended on detailed geological investigations, marine research, engineering, permitting and stakeholder engagement.
- The Taranaki VTM Project will bring significant benefits to the regional and New Zealand's economy as well as contribute to the critical minerals needed for the 'greentech' future.
- Why haven't the wind energy proponents ever approached TTR and discussed their proposals for wind energy in the STB area?
- Notwithstanding this lack of consultation, they seek to prevent TTR from pursuing its lawful development of natural resources, when the STB is big enough for both business activities. This hostility is puzzling?
- Their poorly researched paper omits much relevant information and delivers a misleading case for Offshore Wind Energy (OWE) on a number of key issues including impact on seabirds, the marine environment, marine mammals and permanent impost on the environment and commercial fishing, vessel navigation and mineral resource recovery.

- Their site selection seems to be limited to one wind meter installed on the Kupe platform with no wider investigations of the extensive STB possibilities for OWE.
- It appears this site, superimposed directly over TTR's granted mining permits, is exactly where they propose to establish their towers and infrastructure without any consultation with TTR?
- In any event the OWE economics and GDP benefits stated in the paper are far exceeded by mining of titanomagnetite (VTM) by orders of magnitude as supported and shown by independent expert evidence and recent MBIE ministerial briefing papers.
- The paper lacks evidence of any marine research, geological and geotechnical investigations in support of their proposal.
- If they had done their homework, or consulted with TTR which has extensive marine research information and data from 100's of drill holes in the area, they would know that the seabed here is comprised of unconsolidated super saturated fluidised black sands 10's of metres deep.
- This geological substrate will require massive steel and concrete foundations implanted deep into the sea bed to support 300m towers and generating equipment. These foundations, for each of the 100's of towers, will require 1,000's tonnes of concrete, steel and stabilising chemicals injected into the seabed sands.
- These permanent seabed fixtures, along with the network of interconnecting cables
  draped on the seafloor, will never be recovered or allow any rehabilitation of the benthic
  communities or recovery of the marine ecology possible.
- The foundations, towers, electronics and generation equipment, along with the transmission infrastructure to shore and markets, are made of....mainly iron, vanadium and titanium, exactly what TTR intends to recover.
- The proponents for OWE development in the STB have simply failed to explore their
  options, do any meaningful research or engage with existing interests and stakeholders in
  the area.

With consultation, TTR believes both activities OWE and mineral recovery, can co-exist in the STB with sensible consultation and co-operation and reference to the facts of the proposals.

Dear Minister Watts,

I am writing to let you know more about our planned project to harvest iron sands 22km offshore in the South Taranaki Bight and, in particular, how our project can work alongside proposals to establish offshore wind farms.

The issue of seabed mining and offshore wind farms co-existing off the coast of Taranaki was raised at the Investment Summit you attended and addressed in Auckland last week. We understand offshore wind developers and investors attending the summit advised that it would be 'difficult' to cohabit with seabed mining.

Trans-Tasman Resources (TTR) has invested significantly over many years in attempts to gain the consents required to harvest the iron sands, which contain the critical minerals of iron ore, vanadium and titanium. These minerals are in demand to build the infrastructure economies need as they transition to renewable energy.

TTR is currently preparing its application for fast-track approval for the project, which the New Zealand Institute of Economic Research (NZIER) has assessed will deliver more than 1300 jobs and generate more than \$850 million in total export earnings annually. It is a massive project that will have huge flow-on benefits for all of New Zealand.

Last year a consortium of offshore wind developers issued a briefing paper on their plans to establish an offshore wind farm in the same location as our project in the South Taranaki Bight. Following its release, we wrote to each consortium and suggested we meet to discuss how seabed mining and offshore wind energy can work together. We believe that the two can coexist with good communication and co-operation.

While the two activities cannot occur at the same time, we are strongly of the view that offshore wind can follow seabed mining in a co-ordinated manner. Given the regulatory environment is still being developed to enable the establishment of an offshore wind energy sector, there is merit in offshore wind following the harvest of iron sands.

You will be aware that TTR has government granted exploration and mining permits. We have identified the resource-rich iron sands and have a property right over them in the South Taranaki Bight.

An expert geotechnical report on the implications for any future deployment of jack-up rig platforms or foundations for fixed platforms on the seabed following the harvesting of iron sands found "the presence or otherwise of the tailings doesn't change anything or have any

significant implications for any future deployment and founding of jack-up rig platforms on the seabed". This report satisfied concerns from the oil and gas sector and we are confident it also addresses flags raised by offshore wind farm developers.

Suggestions that the seabed would need up to 50 years to recover before offshore wind farms could be established are simply unfounded.

There does not need to be a choice between harvesting iron sands or offshore wind energy, as both can take place and deliver benefits to New Zealand.




Figure 1: TTR's proposed mining area within the EEZ




Figure 1: TTR's proposed mining area within the EEZ




Figure 1: TTR's proposed mining area within the EEZ




Figure 1: TTR's proposed mining area in the EEZ




Figure 1: TTR's proposed mining area with the EEZ




Figure 1: TTR's proposed mining area within the EEZ




Figure 1: TTR's proposed mining area within the Z




Figure 1: TTR's proposed mining area within the Z




Figure 1: TTR's proposed mining area within the Z




Figure 1: TTR's proposed mining area within the Z




Figure 1: TTR's proposed mining area within the Z

### **Statement to Te Karere**

Trans-Tasman Resources (TTR) is disappointed by the actions of Ngāti Ruanui in seeking the Waitangi Tribunal to take a position on seabed mining.

TTR Executive Chairman Alan Eggers says it is a fact that iwi are included in the Fast-track process and will have an opportunity to have their voices heard.

"Our first convenor conference has been scheduled for next week (7 July) and the panel convenor has invited 36 relevant iwi authorities, treaty settlement groups and other iwi and hapu to participate in this and the Fast-track decision-making process, including Ngāti Ruanui.

"The panel convenor has written a minute detailing this and this is publicly available on the Fast-track website. It is simply incorrect to say iwi voices are not involved in the decisionmaking," Mr Eggers says.

"We would like to be working positively with iwi groups, as there is considerable opportunity for Māori to be involved in the project.

"There will be jobs and training available along with opportunities for Māori to undertake much of the work, especially the marine monitoring and research work that reports direct to the Environmental Protection Authority (EPA) which ensures the project meets all its environmental conditions. We would like iwi to be involved with that work."

Mr Eggers says the Waitangi Tribunal has no expertise or understanding of mining, and has no statutory authority or regulatory function with respect to marine consents.

We are writing to you in response to your letter dated 15 August 2025, in which you have sought a meeting with Te Kaahui o Rauru to discuss the Taranaki VTM project "as a means to better understand [our] position opposing [your] project and to identify where there may be opportunities to find resolution".

#### Your project

As a starting point for any discussion, we note that this project has a long history with prior proceedings concerning opposition (including our own) to the project in both the Environmental Protection Authority (the **Authority**) and the senior courts.

As a result of the Supreme Court decision, this project was due to be reconsidered by the Authority but that process was cut short following your withdrawal of the application on 28 March 2024. We note that this project was announced to be included as a listed project within Schedule 2 of the Fast-track Approvals Act 2024 (the **Act**) as early as 6 October 2024, with that Act being enacted on 24 December 2024. Finally, we note that Trans-Tasman Resources lodged its project listing application for the Taranaki VTM Project on 23 April 2025.

### Your engagement with us to date

In our view, there has been ample opportunity for you to seek meaningful and genuine engagement with Ngaa Rauru Kiitahi. We therefore consider the timing of this request to be extremely disappointing. For the avoidance of doubt:

- We consider that Trans-Tasman Resources has not undertaken, or attempted to undertake, any meaningful engagement with Te Kaahui o Rauru to date in respect of the Taranaki VTM Project.
- That is, for engagement to be meaningful it must also be genuine. Despite having made our views on the proposed activity clear to you over a number of years, we consider that your

approach to the application process(es) to date has not demonstrated any genuine desire to seek to address our significant concerns.

- In particular, your decision to withdraw from the Authority's reconsideration process and later
  make an application for the very same project under the fast-track approvals process, without
  any further discussion with us or any of the iwi parties for that matter, has demonstrated a
  blatant disregard for our strong views on the project (which you continue to be well aware of).
- Our participation in these proceedings over the years has come at an enormous cost (both in time and monetary terms) to our people. There has been little regard shown by Trans-Tasman Resources for these effects.
- As a result of this, it appears clear to us that you are unwilling to allow for any change in outcome
  or approach notwithstanding the project's adverse effects on our traditional rohe and
  maatauranga, which we have continuously reiterated in previous application processes.
- The timing constraints around the present engagement make it impossible for us to arrange a
  hui in the appropriate manner, which we would otherwise ordinarily seek to do.

Notwithstanding these significant concerns with your approach to engagement, we are willing to meet with you, preferably aa-kanohi, given, as you have noted in your letter, the truncated statutory timeframes that apply under the fast-track approvals process.

As a related matter, we note that the Convener has recommended that arrangements be made for a panel briefing session and a site (or wider location) visit, "ideally both to be undertaken prior to the invitation to comment being issued (which will be due on 8 September" (at paragraph 11 of the Minute dated 12 August 2025). We therefore assume that your proposed approach to these matters will be discussed with us at our meeting.

Thank you for meeting with my team to discuss our Taranaki VTM application to harvest iron sands containing critical minerals in the South Taranaki Bight.

While it was good to meet and engage, we accept that you remain opposed to our project.

Despite this, we are committed to working with you to help us both gain a better understanding of each other's positions and to find common ground, where there is.

As we discussed, the 2025 application to gain the approvals needed to mine the seabed is a new application and there has been considerable work done to update and prepare material for the application. This work includes developing a new pre-feasibility study (and metallurgical reports), an independent economic assessment, updated environmental reports on the plume and marine life, and updating consultation documents. The work addresses shortfalls identified in the rulings of the Supreme Court and what came from the Hawera hearing, as far as it went.

We accept there is a lot of information.

At the meeting we also canvassed the cultural effects and impacts, and indicated we didn't feel it was appropriate for Trans-Tasman Resources to interpret the cultural effects as that is best done by mana whenua. While TTR had sought and paid for a cultural impact statement from you some years ago, this was never forthcoming.

It was good to agree on some next steps from our meeting. These include sharing the project management conditions with you, providing details of interactions and payments in regards to sourcing a cultural impact statement from you, and enabling our lawyers to co-operate better by copying in when there is any information provided to the expert panel. We also look forward to receiving some feedback from you on a process going forward.

#### 6.3 Consultation Outcomes

#### 6.3.1 Introduction

Further to the consultation described in Section 6.2, TTR's general principle for consultation with the existing interest parties has been through the following process:

- TTR provided a suite of project information that described the project that consent was being requested and included the results of various technical reports / assessments that support the application. All stakeholders were provided the opportunity to request detail reports and further information on the project. TTR required parties to sign a Confidentiality Agreement as the detailed technical and scientific reports contained information that was developed at significant cost and effort to TTR, and its uncontrolled release would not only disqualify future patent applications but would cause unreasonable prejudice to TTR's commercial position as it could be used by its competitors to their advantage. In circumstances where parties were not prepared to sign this agreement the sensitive information was not released.
- Following the provision of the project information, TTR invited parties to participate in
  meetings providing the opportunity to discuss the project and to enable face to face
  discussions to occur. Not all parties accepted the invitation however, in some cases only
  a single meeting occurred and for others many meetings took place.
- Where requested, generally between meetings, TTR provided additional information in response to queries, comments and questions raised by interested parties. This information typically consisted of draft conditions, management plans, and responses to specific queries on matters within technical reports that warranted further technical response. This information allowed for various parties to provide feedback into the project specifically around draft conditions and management plans. Where relevant to the project and considered appropriate by TTR, this feedback has been incorporated into the related documents.
- As a final stage of consultation, TTR attempted to reach an agreed position with parties that identified points of agreement and disagreement. Where prepared, these have been included in the summaries below.

The sub-sections below provide an overview of the consultation undertaken with particular 'existing interest' parties and stakeholders.

### 6.3.2 Ngāti Ruanui

A disappointing aspect of the engagement process to date has been the lack of participation by Te Runanga o Ngāti Ruanui, the recognised mandated representative body for Ngāti Ruanui on environmental matters.

From the beginning TTR has made it clear that it recognised Ngāti Ruanui's position as tangata whenua. Ngāti Ruanui made a point of referring to the legal costs it had accrued as part of TTR's withdrawn appeal and identified it as a potential stumbling block. As a gesture of good faith and in the interest of developing a positive, open and principled engagement, TTR agreed to cover all Ngāti Ruanui's legal costs relating to TTR's withdrawn appeal. Despite this, and other continued initiatives, any attempts to engage constructively with Ngāti Ruanui (which have been documented), have met with little success.

As part of this new application process, TTR has only been able to meet with Ngāti Ruanui on one occasion, which was in September 2015. The meeting concluded with an agreement that Ngāti Ruanui would complete a CIA, which would be financed by TTR. However, despite continuing

efforts from TTR, Ngāti Ruanui are yet to progress this, and as such TTR engaged an independent consultant to complete a CVA (summarised in Section 4.11.2). TTR and the independent consultant remain open to consulting with Ngāti Ruanui at any stage throughout the consenting process.

On 16 May 2016, TTR sent an email to Ngāti Ruanui in good faith. The email stated that as TTR continued to maintain a desire to develop a meaningful, positive, and open relationship with mana whenua they included a copy of the proposed consent conditions specifically identifying the conditions which were drafted in an attempt to provide for ongoing tangata whenua involvement, as well as proposed measures to address effects on cultural values.

In a response to TTR's email, Ms Debbie Packer (on behalf of Ngāti Ruanui) on 20 May 2016, made the following unsubstantiated assertions about the breakdown in consultation, which have been summarised below:

- That despite having received the proposed conditions, comprehensive stakeholder package, being part of the lwi fishing forum and personally meeting with the management of TTR, Ngāti Ruanui continued to be unclear about TTR's environmental practises, and restated their need of all TTR's detailed science data in order to assess the validity of the conditions proposed;
- That they regarded the required confidentiality agreement as non-commercial because
  it placed restrictions on Ngāti Ruanui. Ngāti Ruanui regarded this is an unprecedented
  move and pointed to this as being the single aspect responsible for the breakdown in
  the engagement process;
- That TTR's intent to show good faith and communicate with Ngāti Ruanui continued to fall short of Ngāti Ruanui's best practice engagement protocols that they routinely apply to the numerous energy companies they engage with;
- That despite Ngāti Ruanui continuously appealing for transparency of information, specifically the science environmental research, Ngāti Ruanui considered that TTR has 'stonewalled' them, leaving mana whenua as kaitiaki in the unenviable position of not being able to qualify or determine TTR's best environmental practises;
- That Ngāti Ruanui did not support or recognise the report provided by the lwi Fisheries
  Forum and were offended that Ngāti Ruanui would be expected to complete a CIA in
  the absence of environmental data;
- That Ngāti Ruanui had made numerous attempts to communicate their concerns to TTR through the Chair, legal counsel and more recently they engaged a communications advisor to facilitate their view to TTR, which has not been validated;
- That Ngāti Ruanui has met with EPA at the Iwi Chairs Forum in Waitangi suggesting solutions to get objective environmental research with Ngāti Ruanui offering to pay half as TTR wouldn't disclose information. Ngāti Ruanui assert that this was initially supported but when the EPA manager returned to Wellington the offer was rescinded;
- That the communications and politics involving the undermining of Ngāti Ruanui from TTR (as shared with TTR Chair and TTR legal counsel) has been fraught and resulted in Ngāti Ruanui displacement through this process;
- That Ngāti Ruanui has attempted numerous times to resolve and will remain open minded however, until TTR shares it data, there is little that can be done at this stage; and

 That Ngāti Ruanui noted that under the previous application, TTR disclosed all information, although the methodology kept changing, the communications was of higher quality.

On 26 May 2016, TTR responded to Ms Packer's email stating:

"Whilst we do not agree with the assertions you make regarding the provision of this information I can only reiterate that TTR and its Board remains committed to establishing a relationship with Ngāti Ruanui and as such, TTR continues to be available to meet at your convenience to discuss the project and all the information provided."

No further response has since been received from Ngāti Ruanui.

Despite the unsuccessful consultation process, TTR recognises that Ngāti Ruanui holds mana whenua over the project area and acknowledge that Ngāti Ruanui did not support the first marine consent application and, therefore, believe they are unlikely to support this application.

TTR has provided Ngāti Ruanui with all the available information throughout the process and has provided multiple opportunities to access the detailed and, in some case confidential, scientific reports. TTR has continued to try to engage with Ngāti Ruanui to better understand their concerns and where possible find ways to address them. TTR remains willing to engage with them at any time. However, in order to progress the marine consent and marine discharge consent applications, as described in Section 4.11.2 of this IA, TTR engaged Mr Tahu Potiki to provide a CVA of the project area with a specific focus on Ngāti Ruanui.

### 6.3.3 Te Tai Hauauru lwi Fishing Forum


Consultation was undertaken with the lwi Fisheries Forum as part of the pre-application process for this application. As part of the consultation, TTR was afforded the opportunity to present their stakeholder engagement package to the lwi Fisheries Forum at Pungarehu Marae up the Whanganui River. The information was well received and some good discussions evolved. TTR has had a very good working relationship with the lwi Fisheries Forum.


As a direct result of the consultation process, the Iwi Fisheries Forum prepared the Forum Report, a detailed cultural values assessment that informs TTR of their customary interests within the project area and includes potential measures to be incorporated into the project to provide for any potential adverse cultural impacts that may result from the project. Where these measures were directly related to the project they have been included in the proposed consent conditions provided for in Attachment 1 of this IA. The Forum Report and mitigation measures have been discussed in detail in Section 4.11.3 of this IA.


### 6.3.4 Nga Ruahine


Engagement and discussions with the CEO and Chair of Te Korowai o Nga Ruahine have occurred to brief them about the status of our new marine consent and marine discharge consent application. TTR met with CEO and Chair formally to present TTR's stakeholder engagement package and respond immediately to any issues that were raised. TTR encouraged the leadership of Nga Ruahine to communicate what other engagements they would like within their iwi. There were no requests made however, recently they did ask for a confidentiality agreement to enable them to access the more detailed reports. TTR sent Te Korowai o Nga Ruahine a confidentiality agreement to sign late June 2016, however no response has been received to date.

As identified above, consultation was undertaken with the lwi Fisheries Forum, of which Nga Ruahine are a part of, as part of the pre-application process for this application.

Record of Telephone Meeting 27 January 2016 Alan J Eggers call to Debbie Packer Chair Ngati Ruanui

Following our meeting with Ngati Ruanui in Hawera in September 2015 and numerous requests for a one on one meeting for AJE and Debbie Packer (all documented by TTR) Mike Holm arranged a phone meeting for 1100 NZST 27 January 2016 for AJE with Debbie Packer.

The phone meeting lasted around 40 minutes. A summary of the key issues covered and comments

AJE thanked Debbie for taking the call, suggested that a one on one meeting would have been preferably but due to AJE's travel commitments and Debbie's schedule over recent months this had not been achieved.

AJE advised that TTR remained on schedule to lodge its Marine Consent application with EPA in mid February 2016 and, despite our agreement to work together to deal with Ngati Ruanui's assessment of the application and supporting information and for Ngati Ruanui to undertake a cultural impact assessment (CIA) based on the TTR information no progress had been made.

It was explained that time is now very short and TTR would like to resolve with Ngati Ruanui its concerns regarding the confidentiality of its information, deal with any concerns they have over the STB iron sands mining proposal and have the CIA completed.

Debbie suggested that despite the delivery of the Stakeholder Engagement Package to Ngati Ruanui little had changed from the original application and she made a number of unsubstantiated claims including:

Ngati Ruanui have been trying to communicate with TTR regularly with an established email trail to no effect as TTR doesn't respond;

Ngati Ruanui had been unable to get responses to its concerns from TTR and had been forced to go to the media (4 December 2015 Taranaki Times) to get answers;

Ngati Ruanui has been approached by the oil & gas industry including Shell and Origin, the fishing industry, iwi chairs and groups and community leaders, stakeholders and recreational groups with their concerns and expressing their frustration at TTR not providing information, not being transparent and just dismissing their concerns and questions with "spin" and comments to the effect that all their questions and concerns on the proposal have been addressed;

TTR are going around stating that if Ngati Ruanui don't complete the CIA TTR will get someone else to complete the assessment;

TTR's story is "shakey with no credibility";

Ngati Ruanui have been requesting answers to a list of 35 questions from TTR for months with no response;

Ngati Ruanui has a list of names of community and iwi leaders including lawyers and accountants that have expressed serious concerns about the validity of our information, the lack of information and transparency and have a different insight into the proposal than TTR with a huge "gap in our story":

TTR has consistently failed to address any of these questions or concerns;

TTR are really just here to "rape and pillage" whilst promising jobs and developments that don't exist:

Ngati Ruanui's environmental department (Graham Young) has over 35 years experience in these sorts of developments and hasn't been able to get his concerns and questions answered;

There is a lack of real information from TTR being provided;

TTR are insisting that Ngati Ruanui provide the names of the 7,000 iwi constituents to provide the information:

Debbie was upset about being "pestered for a meeting" during her holidays over the Xmas New Year period: and

TTR's staff, consultants and advisers do not have the "mana" to present creditably or transparently and the information is lacking and doesn't address their concerns and issues.

She would look at getting information requested to TTR when she returns from leave.

Despite her agreeing to a meeting in the next week or 2 prior to Xmas Debbie hadn't made herself available or responded to emails or phone calls to agree to a convenient time and place to meet.

AJE explained the need for the confidentiality agreements and that they only applied to the underlying expert reports for their experts to review should they require them and there would be no restriction on Ngati Ruanui discussing the Stakeholder Engagement package information with their 7.000 constituents:

AJE advised that TTR were not getting any other group to complete the CIA;

Advise we have full confidence in all our staff, consultants and advisers and in the accuracy and validity of the information we are providing; and

Ngati Ruanui would be addressing the iwi chairs at Whitangi Day meetings and will be advising that due to the lack of information, transparency and unanswered questions they could not recommend any support for the project and it should be opposed.

AJE requested that Debbie and Ngati Ruanui:

Send to AJE their list of unanswered questions so they can be addressed;

Send the list of 35 community leaders and stakeholders with concerns so we can contact them and address their issues; and


Advise when they will have the CIA completed (as agreed in September 2015) and costs involved for TTR to complete its Marine Consent application.


AJE explained that TTR had made every possible effort to engage with Ngati Ruanui positively and work with them to address their concerns and have the CIA prepared with no material progress over 12 months.

### INQUIRY INTO SEABED MINING - IWI CONSULTATION AND COSTS

#### **Dear Stuart**

I refer to your email of 19 July 2023 requesting clarification of payments made to Ngāti Ruanui to prepare a Cultural Impact Statement (CIS) for Trans-Tasman Resources Limited's (TTR) applications for environmental consents to the Environmental Protection Authority (EPA).

TTR has prepared two EPA applications for environmental marine and discharge consents as required under the EEZ Act for its proposed iron sands mining operation in the South Taranaki Bight (STB).

These consents, applied for in 2013 and 2016, require CIS's generally prepared by the relevant iwi with mana whenua over the area of the proposed operations.

We identified Te Runanga o Ngāti Ruanui (Ngāti Ruanui) as mana whenua for the area of TTR's proposed operations and their role and obligations as kaitiaki over the rohe within the area.

In 2013, for our first EPA environmental consent application, Ms Debbie Ngarewa-Packer for Ngāti Ruanui agreed to provide the CIS for our application provided we covered their costs in preparing their report.

From 1 April 2013 to 31 March 2014 TTR made four payments to Ngāti Ruanui for a total of \$63,377.65 for them to prepare the CIS (refer attached Transaction Costs Ngāti Ruanui 2013 2015). Ngāti Ruanui failed to produce a CIS for TTR.

In June 2014 the EPA's Decision Making Committee declined TTR's first environmental consent application. TTR immediately appealed this decision to the High Court.

In December 2014 TTR dropped its appeal to the High Court in favour of preparing and lodging a new application with the EPA for the marine and discharge consents.

As part of preparing the second EPA application we re-engaged with Ngāti Ruanui and asked them to prepare the required CIS.

On 18 February 2015 Ms Debbie Ngarewa-Packer agreed for Ngāti Ruanui to prepare the CIS provided TTR paid their legal costs associated with dealing with TTR's 2014 appeal to High Court (refer Ngāti Ruanui Emails Court Costs 2015).

On 19 February 2015 TTR made a payment to Ocean Law in Nelson for \$7,518.79 for Ngāti Ruanui's legal costs (refer attached Transaction Costs Ngāti Ruanui 2013 2015).

On 3 September 2015 Alan J Eggers, Shawn Thompson and Tokatumoana Walden (TTR management) met with Ms Packer and her advisers in Hawera where she again committed to provide the CIS to enable TTR to complete its second EPA application by early 2016.

On 27 January 2016, due to lack of progress by Ngāti Ruanui in preparing and delivering the agreed CIS (for which TTR had agreed to pay any further cost to prepare) Alan J Eggers had a phone meeting with Ms Packer to endeavour to meet her concerns and have the CIS delivered (refer attached Ngāti Ruanui Phone Meeting Notes 27Jan16).

On 17 February 2016 TTR's legal advisers Atkins Holm Majurey (AHM) wrote to Ms Ngarewa-Packer requesting a meeting to resolve outstanding issues and have the CIS report completed (refer attached AHM letter to Debbie Packer 17 February 2016).

From February to April 2016 TTR paid AHM \$20,450.91 for costs directly associated with Ngāti Ruanui's preparation of the CIS (refer attached AHM Invoices Ngāti Ruanui February April 2016).

Due to lack of progress with Ngāti Ruanui in preparing the CIS TTR engaged nearby iwi to prepare a Cultural Values Assessment (CVA). In April 2016 TTR engaged Tahu Potiki and Buddy Mikaere to complete the CVA in 2016 and provide expert evidence for the EPA hearing in 2017.

On 20 May 2016 TTR paid Tahu Potiki \$21,065.00 (refer attached Tahu Potiki Invoice 20May16) and from November 2016 to March 2017 paid Buddy Mikaere \$30,039.79 (refer attached Buddy Mikaere Payments 2016 2017).

In October 2016 Ngāti Ruanui then sought to further frustrate and delay the EPA hearing process by seeking an extension of time in order to allow Ngāti Ruanui to consider and consult on the cultural impacts of the application, including TTR's CVA.

This is after TTR first paid Ngāti Ruanui \$16,369.10 on 1 April 2013 to assess the application and prepare a CIS (see above). AHM wrote to EPA in response to Ngāti Ruanui's request noting TTR had been actively engaged with Ngāti Ruanui since September 2014 on their commitment to complete a CIS that was never provided (refer attached AHM Letter to EPA Ngāti Ruanui 11Oct16).

In summary, TTR has directly paid Ngāti Ruanui \$70,886.44 to prepare a CIS they committed to provide but never did.

TTR has paid Tahu Potiki and Buddy Mikaere \$51,104.79 to provide a CVA and evidence that Ngāti Ruanui committed to provide.

Additional legal fees were paid to AHM of \$20,450.91 to have Ngāti Ruanui meet their commitments to provide a CIS.

In March and April 2017, during the EPA hearing process, we further emailed Ms Debbie Ngarewa-Packer twice requesting a meeting, or a call, to discuss how we might meaningfully engage in the future and re-affirming our commitment to this process (refer attached TTR Engagement with Ngāti Ruanui emails 16Mar 15Apr17). These two requests went unanswered.

We remain committed to establishing a mutually beneficial relationship with Ngāti Ruanui, and other tangata whenua groups who have a relationship with the South Taranaki Bight, and to engage with them in good faith.

This letter is in response to your request to begin engagement and consultation regarding the Trans-Tasman Resources (TTR), Taranaki VTM Project. I understand that three Board election cycles have occurred since you last engaged with Te Korowai o Ngāruahine Trust (Te Korowai). While you have provided a list of matters you wish to address for the purposes of your Fast-track application, it is important that we first meet kanohi ki te kanohi.

We propose the following options to meet at our tari, 40A Union Street, Te Hāwera:
