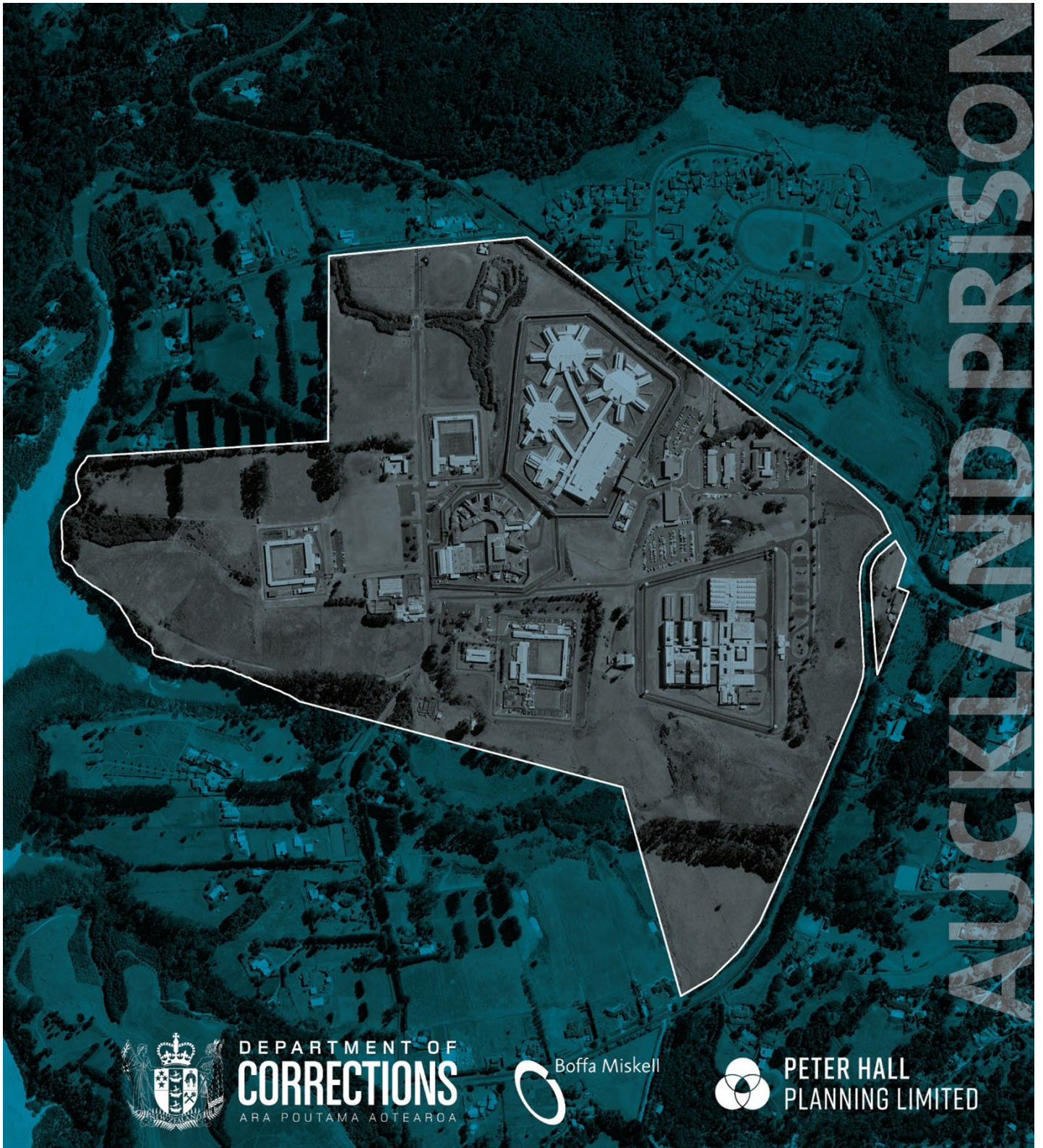

Expert Statements
