

## Appendix E: Definition of Treaty Settlement Land

Treaty Settlement Land is defined in the **Auckland Unitary Plan (Operative in Part)**, Chapter J1 Definitions as:

### **Treaty settlement land**

Property which is either:

- vested with claimant groups by the Crown as a result of Treaty settlement legislation and final deeds of settlement; or
- acquired by a claimant group from the Crown pursuant to a right of first refusal process provided that the properties were specifically identified by reference to site or title in Treaty settlement legislation enacted prior to the date on which the Unitary Plan became operative as Right of First Refusal land for that claimant group.

Includes:

- cultural redress properties;
- commercial redress properties including:
  - properties returned via deferred selection,
  - properties transferred to other iwi, hapū or whānau entities associated or affiliated with the claimant group; and
  - properties transferred to a company in which the claimant group holds a controlling interest.

Excludes:

- unspecified properties within geographic areas over which claimant groups have been awarded Right of First Refusal in Treaty settlement legislation;
- any properties over which claimant groups have been awarded Right of First Refusal in Treaty settlement legislation enacted after the date on which the Unitary Plan became operative;
- properties covered by Statutory Acknowledgement or Deed of Recognition but not owned by claimant groups;
- properties in which the claimant group, or an iwi, hapū or whānau entity associated or affiliated with the claimant group, no longer retains a legal freehold interest;
- properties leased by the claimant group to an unrelated entity for a term which, including renewals, is or could be more than 35 years; and
- properties transferred to a company in which the claimant group has a minority interest.

The Rangitootuni site, legally described as Lot 1 and 2 DP 590677 qualifies as **Treaty Settlement Land**.

The property is vested in Te Kawerau ā Maki as a result of the Te Kawerau ā Maki Claims Settlement Act 2015.

The property is specifically identified in TE KAWERAU A MAKI and THE TRUSTEES OF TE KAWERAU IWI SETTLEMENT TRUST and THE CROWN DEED OF SETTLEMENT OF HISTORICAL CLAIMS, dated 22 February 2014, section 6 Financial and Commercial Redress:

## **6 FINANCIAL AND COMMERCIAL REDRESS**

### **FINANCIAL REDRESS**

- 6.1 The Crown is to provide the financial and commercial redress amount of \$6,500,000 by transferring the Riverhead Forest licensed land the transfer value of which is \$6,500,000.

### **RIVERHEAD FOREST LICENSED LAND**

- 6.2 The Crown must transfer the Riverhead Forest licensed land to the governance entity on the settlement date.
- 6.3 The Riverhead Forest licensed land is to be –
- 6.3.1 transferred by the Crown to the governance entity on the settlement date –
- (a) as part of the redress to settle the historical claims, and without any other consideration to be paid or provided by the governance entity or any other person; and
- (b) on the terms of transfer in part 8 of the property redress schedule; and
- 6.3.2 as described, and is to have the transfer value provided, in part 3 of the property redress schedule.
- 6.4 The settlement legislation will, on the terms provided by sections 93 to 103 of the draft settlement bill, provide for the following in relation to the Riverhead Forest licensed land:
- 6.4.1 its transfer by the Crown to the governance entity;
- 6.4.2 it to cease to be Crown forest land upon registration of the transfer;
- 6.4.3 the governance entity to be, from the settlement date, in relation to the licensed land, –
- (a) a confirmed beneficiary under clause 11.1 of the Crown forestry rental trust deed; and
- (b) entitled to the rental proceeds since the commencement of the Crown forestry licence;
- 6.4.4 the Crown to give notice under section 17(4)(b) of the Crown Forest Assets

- 6.4.4 the Crown to give notice under section 17(4)(b) of the Crown Forest Assets Act 1989 terminating the Crown forestry licence in so far as it relates to the licensed land at the expiry of the period determined under that section, as if –

### 6: FINANCIAL AND COMMERCIAL REDRESS

- (a) the Waitangi Tribunal had made a recommendation under section 8HB(1)(a) of the Treaty of Waitangi Act 1975 for return of the licensed land to Maori ownership; and
  - (b) the Waitangi Tribunal's recommendation became final on settlement date;
- 6.4.5 the governance entity to be the licensor under the Crown forestry licence as if the licensed land had been returned to Maori ownership on the settlement date under section 36 of the Crown Forest Assets Act 1989; but without section 36(1)(b) of the Crown Forest Assets Act 1989 applying;
- 6.4.6 rights of access to areas that are wahi tapu.
