My full name is James Diarmid Paxton. I am an urban designer and landscape architect and also a Director at Reset Urban Design Limited (Reset).

Qualifications and Experience

I hold a Master of Urban Design from The University of Auckland (2022) and a Bachelor of Landscape Architecture (Hons) from UNITEC Institute of Technology (2007). I am a registered member of the New Zealand Institute of Landscape Architects Tuia Pita Ora and a member of the Urban Design Forum Aotearoa.

I have been practising for 18 years as an urban designer/landscape architect working on a wide range of urban design and landscape architecture projects across Aotearoa New Zealand. Many projects have involved preparing reports and evidence, which address matters of visual impact and landscape effects concerning proposed development. The most recent examples of my experience, with relevance to this project, include:

- Private Plan Change 84 Mangawhai Hills a 220 hectare development master plan guided by best
 practise urban design and landscape architecture principles that provide for high quality large lot
 residential development set in an extensive natural landscape, framed by indigenous vegetation,
 wetlands and water systems. This included preparing a comprehensive Landscape & Visual Effects
 Assessment as part of the application, and preparation of landscape evidence.
- Private Plan Change 93 Warkworth South providing urban design expert evidence for Submitters on PPC93. This included authoring the Woodcocks Design Statement, Woodcocks Structure Plan, concept masterplan and yield scenario and an accompanying technical memo, and preparing evidence in support of the Landowners submissions.
- Private Plan Change 108 Crestview Rise request to rezone approximately 2 hectares of land in Papakura from Rural Countryside Living to a Residential Mixed Housing Urban Zone. This included preparing a comprehensive Landscape & Visual Effects Assessment as part of the application, and preparation of landscape evidence.
- Fast-track consenting application for Rotokauri Greenway & Arterial and Resource Consent Application for the Stage 1 subdivision, in Hamilton. This included preparing the Landscape and Urban Design Report, and the Landscape and Visual Effects Assessment for the application.
- Fast-track consenting application for Te Tauoma Stage 1B residential development, Tamaki This included preparing a comprehensive Landscape & Visual Effects Assessment as part of the application.
- Fast-track consenting application for 1 Hansen Road Worker Accommodation, Frankton, Queenstown This included preparing a comprehensive Landscape & Visual Effects Assessment as part of the
 application.
- Bellfield Estate and Opaheke Park a 600-lot residential development in Papakura delivered in stages
 which includes a stream and the adjacent 20 hectare Opaheke Park which also functions as an artificial
 wetland and flood detention area.
