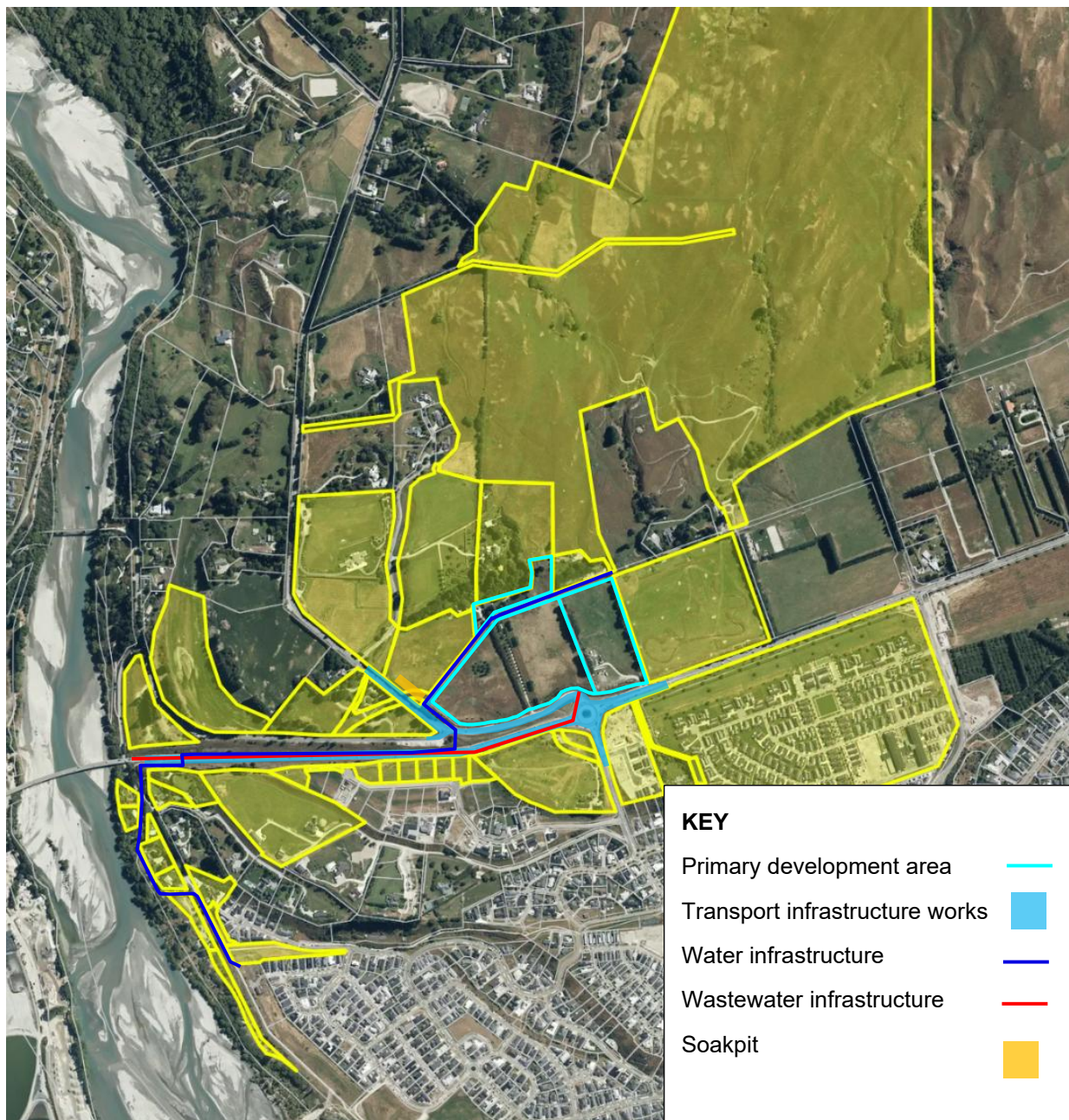


FIGURE 1: ADJOINING SITES HIGHLIGHTED IN YELLOW. SOURCE: GRIP MAPS.



In accordance with clause 5(1)(d) of Schedule 5 of the FTAA, a full list of the owners and occupiers of the land adjacent to the Site is provided in the below table. The location of adjoining properties is illustrated in the below **Figure 1**.

The Applicant has identified the owners of adjacent land using publicly available property records. As occupier information is not publicly available through LINZ or council databases, reasonable enquiries were undertaken to identify occupiers, including site observations and a review of publicly accessible records.
