The Director-General of Conservation and the Minister of Conservation (the **Director-General**)
Wellington International Airport Limited (the **Wildlife Approval Holder**)

BACKGROUND

- A. The Director-General of Conservation and the Minister of Conservation are empowered to issue authorisations or consents for specified acts under the Wildlife Act 1953.
- B. The Wildlife Approval Holder proposes to replace and construct the Southern Seawall, including the Eastern Bank Remediation Area, and in order to facilitate those works to establish and use the Moa Point Construction Yard (the **Moa Point Yard**) and Miramar Golf Course Construction Yard (the **MGC Yard**), and to address the effects of the Project on kororā to establish two kororā colonies (collectively referred to as **the Project**).
- C. The Wildlife Approval Holder has applied for a wildlife approval under the Fast-track Approvals Act 2024 in relation to the Project.
- D. A wildlife approval granted under the Fast-track Approvals Act 2024 has force and effect for its duration, and according to its terms and conditions, as a lawful authority for the purposes of Part 5 of the Wildlife Act 1953 for the act or omission for which the approval was granted and is treated as if it were granted under that Act.
- E. This wildlife approval under the Fast-track Approvals Act 2024 in relation to the Project was granted by an expert panel on [add date].

OPERATIVE PARTS

The Wildlife Approval Holder has been authorised by an expert panel under the Fast-track Approvals Act 2024 to undertake the activities specified in this approval, subject to the terms and conditions contained in this approval and its schedules.

SCHEDULE 1: AUTHORISED ACTIVITY

3. SCHEDULE 2: STANDARD TERMS AND CONDITIONS OF THE APPROVAL

1. Interpretation

- 1.1 ~~The Wildlife Approval Holder must provide a copy of these conditions to its employees, contractors or agents carrying out the Authorised Activity, and explain the obligations under the conditions.~~
- 1.2 Where obligations bind more than one person, those obligations bind those persons jointly and separately.

2. What is being authorised?

- 2.1 ~~The Wildlife Approval Holder is only allowed to carry out the Authorised Activity may only be carried out~~ on the Land described in Schedule 1, Item 2.
- 2.2 Any arrangements necessary for access over private land or leased land are the responsibility of the Wildlife Approval Holder.
- 2.3 The Wildlife Approval Holder must advise the Department of Conservation's local Operations Manager(s) (wellington@doc.govt.nz) prior to carrying out the Authorised Activity in the District (where possible, one week prior), when the Wildlife Approval Holder intends to carry out the Authorised Activity.
- 2.4 ~~The Wildlife Approval Holder and Authorised Personnel must carry a copy of this approval with them at all times while carrying out the Authorised Activity. A copy of this Approval must be available on site at all times while carrying out the Authorised Activity.~~
- 2.5 ~~The Wildlife Approval Holder may publish authorised research results.~~
- 2.6 The Wildlife Approval Holder must immediately notify the Director-General of any taxa found which are new to science. In addition, the ~~Wildlife Approval~~ ~~Authority~~ Holder must lodge holotype specimens and a voucher specimen of any new taxa with a recognised national collection.

3. Who is authorised?

- 3.1 ~~Only the Wildlife Approval Holder and the~~ Authorised Personnel described in Schedule 1, Item 3 are authorised to carry out the Authorised Activity, unless otherwise agreed in writing by the Director-General.

4. How long is the approval for – the Term?

4.1 This approval commences and ends on the dates set out in Schedule 1, Item 4.

5. What are the liabilities?

- 5.1 The Wildlife Approval Holder agrees to exercise the approval at the ~~Wildlife Approval Holder's~~ its own risk and releases, to the full extent permitted by law, the Director-General and the Director-General's employees and agents from all claims and demands of any kind and from all liability which may arise in respect of any accident, damage, or injury occurring to any person or property arising from the Wildlife Approval Holder's exercise of the Approval.
- 5.2 This indemnity is to continue after the expiry or termination of this Approval in respect of any acts or omissions occurring or arising before its expiry or termination.

6. What about compliance with legislation and Director-General's notices and directions?

- 6.1 The Wildlife Approval Holder must comply with all statutes, bylaws and regulations, and other statutory instruments associated with the Land. Without limitation, this includes the Conservation Act 1987 and the Acts listed in the First Schedule of that Act and all applicable health and safety legislation and regulation.

7. Can the Authority be revoked?

- 7.1 The Director-General may revoke this Authority at any time in respect of the whole or any part of the Authorised Activity (pursuant to clause 7(4) of Schedule 7 of the Fast-track Approvals Act 2024) if the Wildlife Approval Authority Holder breaches any of the conditions of this Authority.
- 7.2 If the Director-General intends to revoke this Authority in whole or in part, the Director-General must give the Wildlife Approval Authority Holder such prior notice as is reasonable and necessary in the circumstances.

8. How are notices sent and when are they received?

- 8.1 Any notice to be given under this approval by the Director-General is to be in writing and made by personal delivery, by pre-paid post or email to the Wildlife Approval Holder at the address, ~~fax number~~ or email address specified in Schedule 1, Item 5. Any such notice is to be deemed to have been received:
- (a) in the case of personal delivery, on the date of delivery;
 - (b) in the case of post, on the 3rd working day after posting;
 - (c) in the case of email, on the date receipt of the email is ~~sent provided the email is sent before 5 pm, otherwise it is deemed to have been received at 9 am on the next working day~~ acknowledged by the addressee by return email or otherwise in writing;

8.2 If the Wildlife Approval Holder's details specified in Schedule 1, Item 5 change then the Wildlife Approval Holder must notify the Director-General within 5 working days of such change.

9. What about the payment of costs?

9.1 The Wildlife Approval Holder must pay the standard Department of Conservation charge-out rates for any staff time and mileage required to monitor compliance with this approval and to investigate any alleged breaches of the terms and conditions of it.

10. Are there any Special Conditions?

10.1 Special conditions are specified in Schedule 3. In the event of inconsistency or conflict, the Special Conditions will prevail over this Schedule 2.

11. Can the approval be varied?

11.1 The Wildlife Approval Holder may apply to the Director-General for variations to this approval in accordance with clauses 7(2) and (3) of Schedule 7 of the Fast-track Approvals Act 2024.

SCHEDULE 3: SPECIAL CONDITIONS

1. General

1.1 The Authorised Activity must be carried out in accordance with the documents listed in Schedule 1, Item 1 and in the application to the extent it relates to the Wildlife Approval.

1.2 ~~The provisions of the resource consent conditions (where relevant to this approval) and the Lizard Management Plan form a part of this approval and the Wildlife Approval Holder will undertake the Authorised Activity, in accordance with those management plans and relevant resource consent conditions.~~

2. Amendments to the Lizard Management Plan

2.1 The Wildlife Approval Holder may make minor amendments to the LMP at any time.

2.2 The Wildlife Approval Holder must submit, in writing, any minor amendment(s) to the certified management plan to the Director-General relevant Manager(s) at least ten (10) working days prior to when the works associated with the amendment are to be implemented. The Wildlife Approval Holder must maintain a record of all minor amendments.

2.3 For the purpose of this condition 2, a 'minor amendment' is either:

(a) a small change to the content of the management plan(s) which has either no or a de minimis adverse environmental effect or

(b) a change which would result in an improved environmental outcome.

3. Lizard capture and handling

- 3.1 Capture and handling methods must involve only techniques that minimise the risk of infection or injury to the animal and shall follow those described in the Herpetofauna inventory and monitoring toolbox ~~http://www.doc.govt.nz/our-work/biodiversity-inventory-~~
~~and~~ <http://www.doc.govt.nz/our-work/biodiversity-inventory-and-monitoring/herpetofauna/>.
- 3.2 The Wildlife Approval Holder must sterilise any instruments that come in contact with the lizards and/or are used to collect or measure lizards between each location. A separate holding bag must be used for each animal. All equipment should be thoroughly cleaned and dried between sites.
- 3.3 The ~~Wildlife Approval Authority~~ Holder must ensure lizards are held temporarily in a suitable container (e.g. breathable cloth bag) and placed out of direct sunlight to minimise the risk of overheating, stress and death between capture and salvage, and relocation to the adjoining receiving site.

4. Salvage

- 4.1 If required in writing by the Director-General, the ~~Wildlife~~ Approval Holder must make such improvements to techniques (including catching, handling, releasing, preserving and storing), and take such other steps as directed by the Director-General.

5. Death of wildlife associated with Authorised Activities

- 5.1 If any lizards should die during the approved activities of ~~catch, transfer or liberate~~ ~~catch,~~
~~handle, salvage and relocate,~~ the ~~Wildlife~~ Approval Holder must:
- (a) inform the Wellington DOC Operations Manager (wellington@doc.govt.nz) within 48 hours, chill the body if it can be delivered within 72 hours, or freeze the body if delivery will take longer than 72 hours; and
 - (b) send the body to Massey University Wildlife Postmortem Service for necropsy OR as otherwise advised by the Wellington DOC Operations Manager, along with details of the animal's history; and
 - (c) pay for any costs incurred in investigation of the death of any lizard; and
 - (d) if required by the Wellington DOC Operations Manager, cease the Approved Activity for a period determined by the DOC Operations Manager.

Note: Condition 5.1 is intended to ensure catch, ~~transfer~~ ~~handle, salvage~~ and liberate activities occur according to best practice and does not relate to accidental deaths that may occur during mechanical excavation.

6. Euthanasia

- 6.1 If any lizards are found injured as part of the ~~Approved Activity~~, ~~advice must be sought from the~~
~~Approval Holder shall contact~~ the ~~Authorised Personnel~~ ~~Project Ecologist~~ to get advice on management of the lizard. ~~Injured lizard(s) may be~~ ~~The Approval Holder is Authorised to~~

~~7. Injured protected wildlife and euthanasia~~

~~7.1 If any protected wildlife are incidentally injured as part of the Authorised Activity or in the course of undertaking activities associated with the Project, the Wildlife Approval Holder must contact the Authorised Personnel listed under Schedule 1(3) a suitably qualified person to get advice on management of the protected wildlife, including how to best address the injury.~~

~~7.2 If protected wildlife is incidentally harmed by the Wildlife Approval Holder, the Wildlife Approval Holder will take all reasonable steps to rehabilitate protected wildlife, in line with the advice of a suitably qualified person.~~

~~7.3 The Wildlife Approval Holder is authorised to appoint a qualified veterinarian to euthanise injured animal(s) on the recommendation of the suitably qualified person. Once euthanised, the Wildlife Approval Holder will deal with the protected wildlife in accordance with condition 5.~~

~~7.4 The Wildlife Approval Holder must notify the Department of Conservation's [insert] within twelve (12) hours of euthanising protected wildlife. The notification will include details of the species of wildlife euthanised and personnel involved in the euthanasia of the wildlife.~~

8. Incidental Discovery

8.1 The DOC Operations Manager for Wellington (wellington@doc.govt.nz) is to be contacted immediately for further advice if protected wildlife other than those listed in Schedule 4 are located within the Site or within the release site. A separate application to catch alive, liberate or kill non-authorized species will be required.

9. Reporting

9.1 A report summarising the outcomes of lizard salvaging must be submitted in writing to the DOC Operations Manager for Wellington (wellington@doc.govt.nz) and permissionshamilton@doc.govt.nz ~~by 30 June each year within three months of the salvage being completed. All reporting must include: be undertaken in accordance with the approved Lizard Management Plan.~~

(a) The Project name

(b) The species and number of any animals collected and released

(c) The GPS location (or a detailed map) of the collection point(s) and release point(s)

(d) The results of all surveys, monitoring or research; and

(e) A description of how the LMP was implemented, including

(i) Any difficulties encountered with capture and handling

(ii) How release sites were assessed

(iii) Post-release monitoring; and

(iv) What contingency actions (if any) were required.

10. Ownership of protected wildlife

10.1 All wildlife remains the property of the Crown. This includes any dead wildlife, live wildlife, any parts thereof, any eggs or progeny of the wildlife, genetic material and any replicated genetic material.

10.2 Unless expressly authorised by the Director-General in writing, the Wildlife Approval Holder must not donate, sell or otherwise transfer to any third party any wildlife collected or otherwise obtained under this approval.

11. Review and re-certification


11.1 The Wildlife Approval Holder must review the LMP and resubmit it to the Director-General for certification on or before each date that is the 10th anniversary and the 20th anniversary of the Approval date. The purpose of the review is to reassess habitat conditions and characteristics and update the LMP to reflect current species knowledge, best practice lizard management and mitigation techniques.
