MINUTE OF THE PANEL CONVENER

Delegation (8 April 2025)

[1] The purpose of this Minute is to advise on the delegation of the panel convener's functions, duties and powers.

Background

- [2] On 6 February 2025, I was appointed as the panel convener for the purpose of the Fast-track Approvals Act 2024 (FTAA). On the same date, Helen Atkins and Jennifer Caldwell were appointed as associate conveners.
- [3] Under the FTAA, the panel convener has a quasi-judicial role. The Environmental Protection Authority provides advice and secretariat support to panels and panel conveners. To ensure timely, efficient, consistent, and cost-effective processes¹, the Authority has a registry arrangement to manage listed projects and referral applications.

The delegation

[4] Following consultation with the Minister, and in line with the FTAA's procedural principles - particularly the promotion of efficiency - I have delegated all functions and powers of the panel convener as set out in Appendix 1 to the associate conveners.² In accordance with Schedule 3, clause 2(7) of the FTAA, I

will remain seized of jurisdiction to exercise all delegated functions and powers.

- [5] Adopting a registry approach to manage the applications for approvals, I will have oversight of the South Island matters and Helen Atkins³ and Jennifer Caldwell⁴ (associate convenors) will have oversight of the North Island matters.
- [6] As panel convener, I will:
 - (a) Maintain oversight of the associate conveners.
 - (b) Manage the workload of the associate conveners.
 - (c) Serve as a point of contact for participants engaged with the FTAA.
- [7] In consultation with the associate conveners, I will:
 - (a) Act as a liaison between the conveners, the administrative bodies, and other government departments or agencies.
 - (b) Engage with professional bodies and government departments and agencies to develop Fast-track processes and procedures.
