 - Mineral resource investigation and exploration progression
 - The construction, operation, and maintenance of an underground mine (the Wharekirauponga Underground Mine)
 - The construction, operation, and maintenance of an open pit mine (the Gladstone Open Pit)
 - Associated infrastructure including surface facilities activities, rock stack and stockpile provisions, upgrades to existing processing facilities, and tailings storage facilities
 - Remediation and closure activities.
- 3. Of relevance to the Department of Conservation, the approvals being applied for will include approvals that outside of the FTAA process would typically be required under:
 - The Freshwater Fisheries Regulations 1983 for diversion activities
 - The Wildlife Act 1953 for monitoring, handling, salvage, and relocation activities
 - The Conservation Act 1987 for pest control, monitoring, planting, and structure occupation activities on public conservation land
 - The Crown Minerals Act 1991 for surface access to Crown land (public conservation land) for mining-related activities.
- 4. Throughout the preparation of the Waihi North project, OceanaGold has engaged a wide selection of domestic and international technical experts to assist with the design of the project and the undertaking of assessments of actual and potential environmental effects
