## RE: SANTANA MINERALS LIMITED – BENDIGO-OPHIR GOLD PROJECT – SUBSTANTIVE APPLICATION UNDER SCHEDULE 2 OF THE FAST-TRACK APPROVALS ACT 2024

- 1. We write to confirm that Matakanui Gold Limited ("MGL") as a New Zealand registered company and wholly owned subsidiary of Santana Minerals Limited will be applying for all approvals necessary under the Fast-track Approvals Act 2024 ("FTAA") for the construction, operation, maintenance and eventual closure of the Bendigo-Ophir Gold Project. The Bendigo-Ophir Gold Project is listed in Schedule 2 of the FTAA, and it is intended that an application for the project will be lodged with the Environmental Protection Authority by the end of June 2025.
- 2. The application will seek approval for mining and mining related activities on Bendigo and Ardgour Stations in the Dunstan Mountains of Central Otago, including (but not restricted to):
  - The construction, operation and maintenance of open pit mines at four identified gold deposits named Rise and Shine, Come in Time, Srex and Srex East;
  - The construction, operation and maintenance of an underground mine (the Rise and Shine Underground Mine);
  - Associated ancillary facilities and infrastructure within the lower Shepherds Valley, including the
    establishment of a processing plant, tailings storage facilities, engineered landforms, rock and
    topsoil stockpiles and water storage and treatment facilities;
  - A general and administration area located on the adjoining Ardgour Terrace for non-operational infrastructure; and
  - Remediation and closure activities.
- 3. Of relevance to the Department of Conservation, the approvals being applied for will include approvals that outside of the FTAA process would typically be required under:

- The Freshwater Fisheries Regulations 1983 for diversion activities and the construction of culverts that may impede fish passage (although no fish are present within the project site);
- The Wildlife Act 1953 for surveying, handling, salvage and relocation activities; and
- The Conservation Act 1987 for the relocation of an existing road, road intersection upgrades, crack willow removal activities and the relocation of an existing walking track on public conservation land.
- 4. Throughout the preparation of the Bendigo-Ophir Gold Project, MGL has engaged a wide selection of domestic and international technical experts to assist with the design of the project and the undertaking of assessments of actual and potential environmental effects associated with the project. As a result of the inputs provided by these technical experts the Bendigo-Ophir Gold Project will utilise leading-practise mining methodologies, environmental monitoring methods, and operational controls, management, and reporting measures. Furthermore, MGL will continue to actively engage with relevant administering authorities, government agencies, environmental groups, stakeholders, and members of the community as the project progresses. These commitments will be included in the proposed consent conditions provided as part of the FTAA application.
