Current RMA Applications for Resource Consents

Resource Management Act 1991 (RMA) applications are in process that are substantially the same as the Project seeking the FTA referral approval. These applications are with the Canterbury Regional Council and the Waimakariri District Council. The Applicant for the Council applications is Protranz International Limited.

Protranz International Limited is owned by the same owner of Whiterock Lime Limited (the FTA referral approval Applicant and Project site landowner).
