- 1. As requested I enclose photocopy for Certificate of Title 808/225. You will see that the registered proprietor is Charles George Stanaway not, as you supposed, the Body Corporate.
- 2. This situation goes right back to the Partition Order (P/R 121/48) which is endorsed with Transfer No. 106.152. This was a sale of the half share of Wiremu Huatahi Waaka also known as William Huatahi Walker to Kathrine Hand Hampson. It was confirmed by the Wairiki District Maori Land Board on 13 March 1915. You will note that this date is PRIOR to the date of the Partition Order you have been asked to withdraw, which Order was dated16 June 1921.
- 3. The other half share was sold by the Registrar of the Supreme Court exercising power of sale under Mortgage No.135489 to three Europeans. Sale took place on 30 August 1921 apprantally cutting out the person named in the Partition Order (Hori Taiapua m.a.) so there you have it. Unless the land was legally added to the Incorporation as European Land owned by a Maori at some subsequent date, it seems that it should be excluded as suggested in my letter.
 - 4. I am holding the documents awaiting your action. If I can clarify the position further please let me know.

On the other hand, the inclusion of additional land, including suropean land owned by a maori, is contemplated by Section 45/1967. Two points incline me towards following following Section 26.
