RE: Minor correction to the Bledisloe North Wharf and Fergusson North Berth Extension [FTAA-2503-1028]

On 21 August 2025, the Expert Consenting Panel issued its decision granting approvals relating to the Resource Management Act 1991 for the Bledisloe North Wharf and Fergusson North Berth Extension Project under the Fast-track Approvals Act 2024 (**FTAA**).

A minor error has been identified in *Appendix 2: Bledisloe Wharf List of Plans* of the decision documents relating to the resource consent granted for the Bledisloe North Wharf. Specifically, the approved plans list refers to the following drawing title and reference:

"Plan - pile setout plan 3237885-220-SE-112"

This should correctly read:

"Plan - pile setout plan 3237885-220-SE-113"

A corrected Appendix 2 (Bledisloe Wharf List of Plans) is **attached** for the Panel's consideration. The only change is the replacement of drawing 3237885-220-SE-112 with 3237885-220-SE-113.

Section 89(1) of the FTAA provides:

(1) A panel may, within 20 working days after issuing a decision document under section 88(1), issue an amendment to the document to correct minor omissions, errors, or other defects in it.
