## Notice of Application

On 28 August 2025, Waterfall Park Developments Ltd lodged an application with the Environmental Protection Authority (EPA) for the Ayrburn Screen Hub under the Fast-track Approvals Act 2024 (the Act). The application seeks the following approvals:

an approval described in section 42(4)(a) or (d) (resource consent or designation);

On 12 September 2025 the EPA determined that the application complied with section 46(2) of the Act. On 25 September 2025 the EPA decided under Ministerial delegation that the application does not have competing applications or existing resource consents under section 47 of the Act and has now referred the application to the Ayrburn Screen Hub expert panel (the Panel) for processing and decision.

Certain information in relation to your comments on the application will become public as the EPA will publish a copy of your comments on the Fast-track website.
