

Appendix I1

Site and Adjacent Landowners and Occupiers

Schedule 5, clause 5(1)(d) requires the full name and address of:

- (i) Each owner of the site and of land adjacent to the site; and
- (ii) Each occupier of the site and of land adjacent to the site whom the applicant is able to identify after reasonable inquiry.

Table 1 sets out the owners and occupiers of the site (shaded red), and adjoining land owner and occupiers (shaded blue). The attached map cross-references each party to the corresponding property number. Tāiko has made all reasonable enquiries to identify the owners and occupiers of these properties. Where an occupier is not stated, it is because it is understood that the owner occupies the property.

The list below is based on the details retained on file and using LINZ and the New Zealand Companies Register records. Note that the application site covers farmland and bush areas for which there is no physical address.
